

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

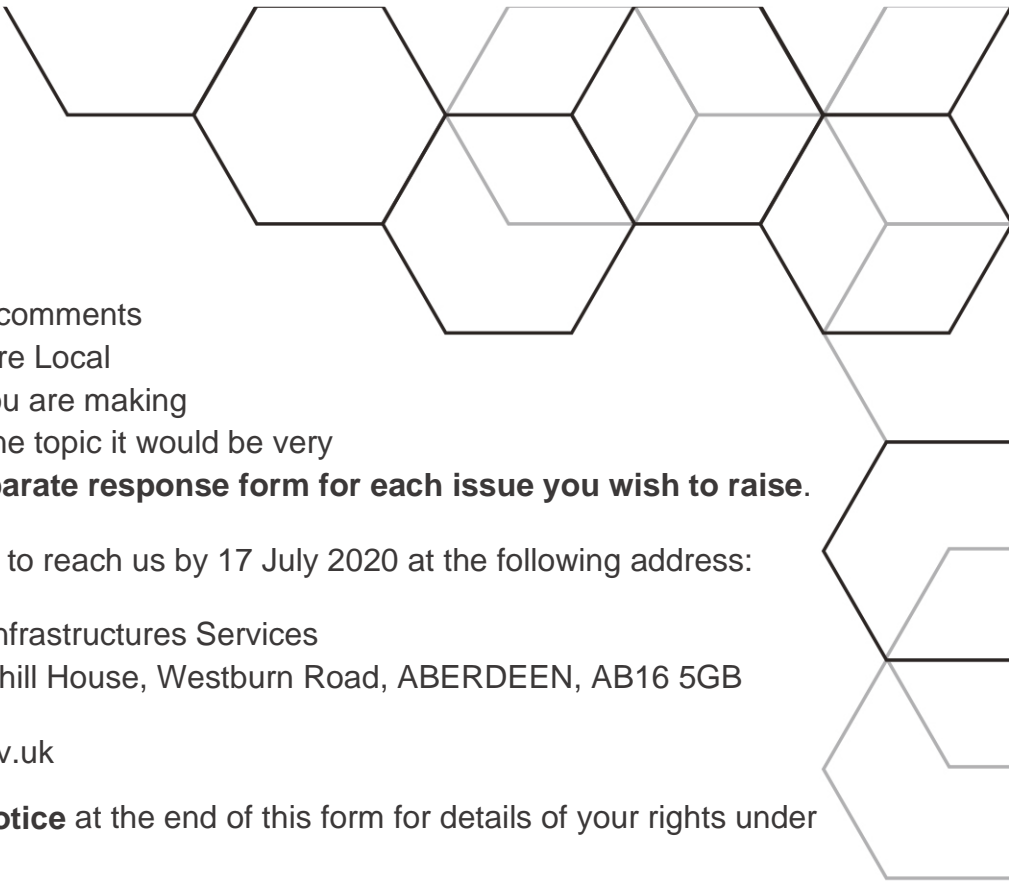

Objection to use of open space as allotments / community growth space

Reason for change:

Insufficient detail in the local development plan regarding R1

Significant concerns over the use of the proposed space

1. Accessibility & parking – Not clear how this will be catered for or achieved. The proposed site is currently inaccessible by road and at the top of a hill? How are people supposed to access the site transfer tools and produce to and from the location if utilised as an allotment?
2. Additional traffic through a housing scheme with young children. Both Averon Park and Kinmohr Rise are residential cul-de-sacs with young families. Concern over additional traffic to and from proposed location and people parking on these streets blocking / restricting access to homes.
3. Will the current paths be retained to allow residents to access this green space? It is unclear based on the information provided.
4. The reserved area is at the top of a hillside - Not exactly an ideal location for allotments.
