

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Reason for change:

I wish to note my concern about the mention of the Potential rail route at R2.

This is in close proximity to the Formartine and Buchan Way which is used extensively and goes some way to align with the Council's priorities to:

- Encourage active lifestyles and promote well-being with a focus on obesity and mental health
- Protect our special environment, including tackling climate change by reducing greenhouse gas emissions as this is a well-used resource for local leisure activities.

As a homeowner in very close proximity to this route I would be affected severely by a railway line in this location due to visual and noise pollution. This would also affect my access to current amenities for my household and many others in the area.

Following the opening of the AWPR the commuting time from Ellon to Aberdeen has been dramatically reduced, both by private vehicle and on public transport. At a time when Council budgets are under increasing pressure, it is non-sensical to progress plans to build a rail link.
