

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Blackburn area R1 – for allotments / community growth space

Reason for change:

This area was designated as protected land in the 2017 plan to contribute to the green network and now it is proposed for the use as allotments.

This area is of significant importance to the dog owners of Blackburn as it is a very popular dog walk / off lead excising area. The area is also used extensively by children of the village during both summer and winter (it is the main sledging area in Blackburn).

There are groves of mature trees in the area along with well established paths and play areas (ie.the big stone). This is also a well-established viewing point over Blackburn and the surrounds; a council bench was installed on the hill a number of years ago and it is common to see the older generation taking the views up there.

It seems unfair that you are proposing that this area is going to be removed from the enjoyment of people of Blackburn as a whole so it can be reserved for a few allotment holders.

It is also a concern that the introduction of the allotments will increase the amount of traffic up to the top of Avern park where the allotment holders will inevitably park in the turning circle/hammer head. This will cause a significant nuisance to the owners of the houses and also restrict the turning of vehicles in the already congested turning area. The parking of cars will also hamper the water board access to the pumping station on the top of the hill.

I would request that you reconsider this plan and revert the land back to protected land to contribute to `green-blue network`
