

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



OBJECTION

Proposal for development at R1, Blackburn

Reason for change:

We wish to object to the above area of land being turned into an allotment site.

The area of grass is a well used open space for children to play, dog walkers and a place to sit at the bench and take in the beauty of the area and relax. In the current climate I have noticed the bench has been used a lot more with individuals sitting on it for breaks whilst out for walks it's a great place to sit and reflect especially in these challenging times.

We as a family use this area often to play with our child as it is close to our house. It is a perfect spot for flying kites, easter egg rolling and sledging in the winter. Many of the local children use this area to play and in the summer it has been know for a football goal to be set up and a safe place to play football away from all traffic and close to home for safety.

There are not many green spaces for children to play close to our house and if this would be taken away it would be very disappointing and detrimental to children's health with less green space available to play.

We feel that turning this site into allotments would be detrimentally to the beauty of the area and to all the local children by taking away green space close to their homes.

We are also concerned about the traffic impact it would have to our street as it would be the main access point to the site. Parking is already an issue on parts of the street to have extra cars coming up to the allotments this would cause more congestion and safety issues for any children being outside.

We feel that there would be better areas for allotments to be established on land that is less cared for, for example down past Burn Park along the river there is loads of open space there away from people's homes. With it being close to the river it would give water access for the allotments. This is also an area that would benefit from being tidied up.
