

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



I would like the proposal for OP2 at Luthermuir to be reconsidered as to the impact on close by residents.
Parking and entrance to OP2 to be separate from Newbigging cottages
Please also consider the environmental impact of the extensive building proposed.
Impact of traffic to the village and North bound A90 junction.

Reason for change:

I bought this house to enjoy the view from my living room window which overlooks fields and the forests. To have this taken away from me is to undermine the health of my mind.

The impact of lengthy building contractors working in the field next to my house fills me with dread. The unsettling and disruption caused is unnecessary.

There are no new services or conveniences in Luthermuir to support such extensive building.

There is limited parking in Newbigging cottages street as it is.

The area considered is home to native species and invertebrates, as well as being a local flying area for bats which live in the near by woods. You will be depriving them of essential food and habits.

The light pollution will also be increased. Another reason I moved here was for the reduction of night light so I can enjoy the stars and sky at night. We are privileged here to enjoy the northern lights and to see comets etc. However, with more street lighting and residential lighting this will all be lost to those living in this street.

It will also increase the volume of traffic through the village and subsequently using the North Bound junction onto the A90. Which is small and has no merger lane.
