

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

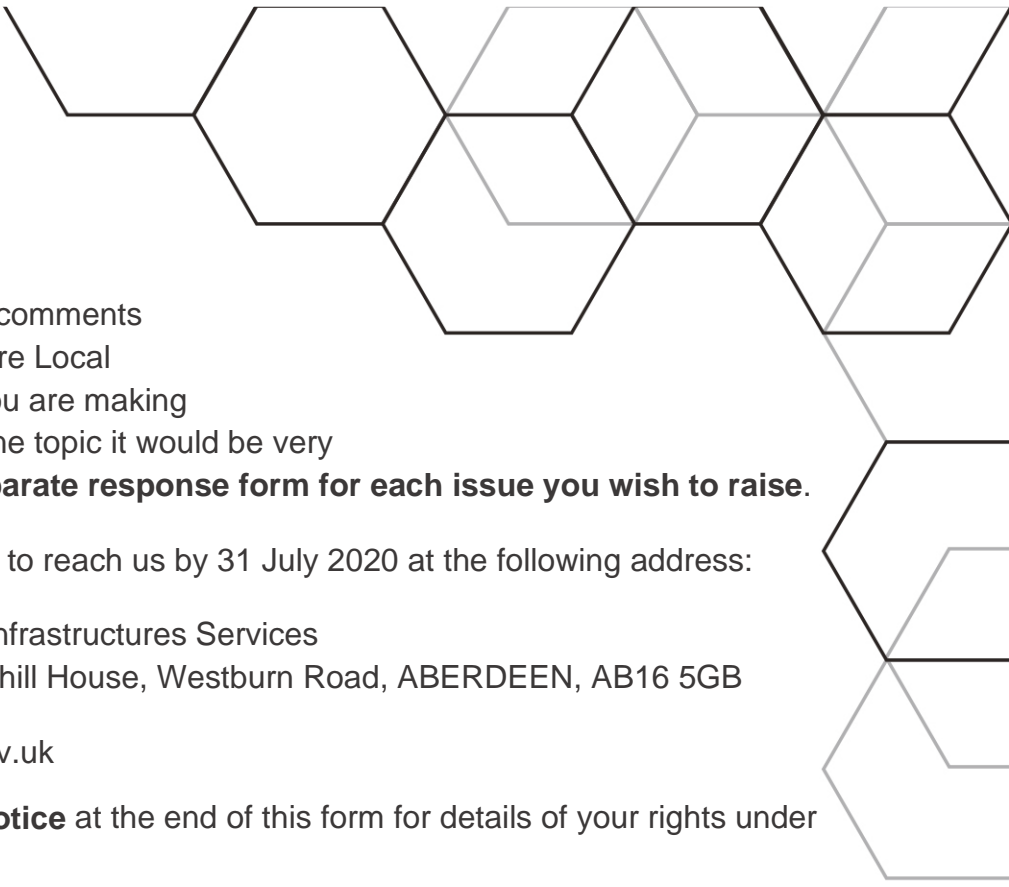

Appendix 7f settlements Marr - Inchmarlo p825 – OP3: Land at East Mains and Auldeer Wood.

Reason for change:

Mission statement clearly states that Inchmarlo is a largely self contained continuing care retirement village set within the policies of the listed Inchmarlo House and extensive historic gardens. The 85 homes, tourism, leisure and business (Hotel and Hotel lodges) proposed for land at East Mains and Auldeer Wood represents a significant departure from the existing continuing care facility. It comprises 3 separate areas forming a large u shaped site on either side of the Glassel road. The sites are not connected to the facility at Inchmarlo or the town of Banchory. It represents opportunistic over-development sprawling into the countryside. If permitted it would add significantly to the traffic on Glassel Road. One also has to question the viability of the proposal in terms of the current economic down turn and many tourist businesses folding, hotels closing.
