

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

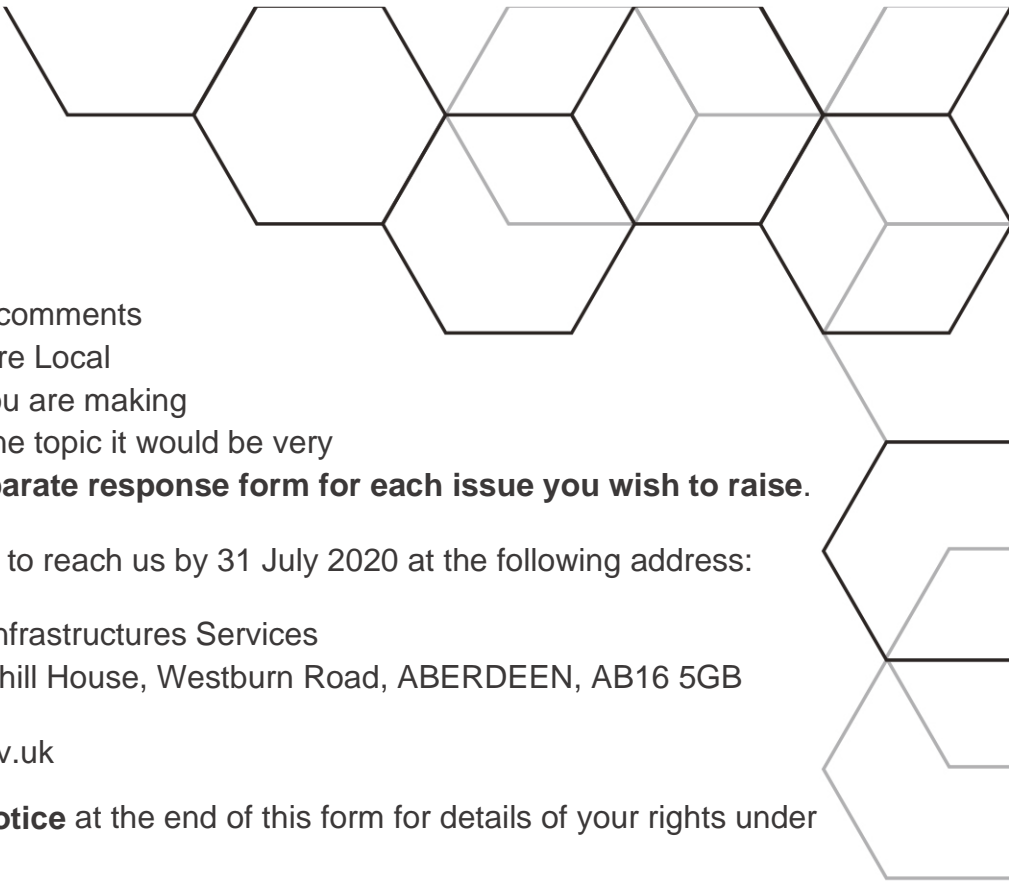

Reason for change:

The open area to the east of P5, Bellfield playing field and adjacent to the area known as the paddock. Is currently up for sale as a development plot. Why isn't this included in the development plan?

I also note that there still a reference to a park and ride scheme. Isn't about time that this concept was scrapped? It very seldom works and the justification for it is rapidly disappearing as private transport migrates from a hydrocarbon driven system to an electrically driven system.

OP6, Glen of Dee and the old nurses' home are really out on a limb, surrounded by forestry. This development looks more like the NHS (or who ever own the site) need to generate cash, than any form of strategic development plan, and would open up the possibility of developing the area which has been clear felled to the south east of the old nurses' home.

OP2 seems like a pincher movement around the north of Banchory, getting closer to the Loch of Leys. I think that the over all planning strategy should ensure that the area to the North of Banchory doesn't become one vast urban sprawl, with little or no amenity space. It's the space and tree which are at the heart of Banchory, and every effort should be made to develop with that in mind, rather than cramming in as many house per hectare as possible.
