

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

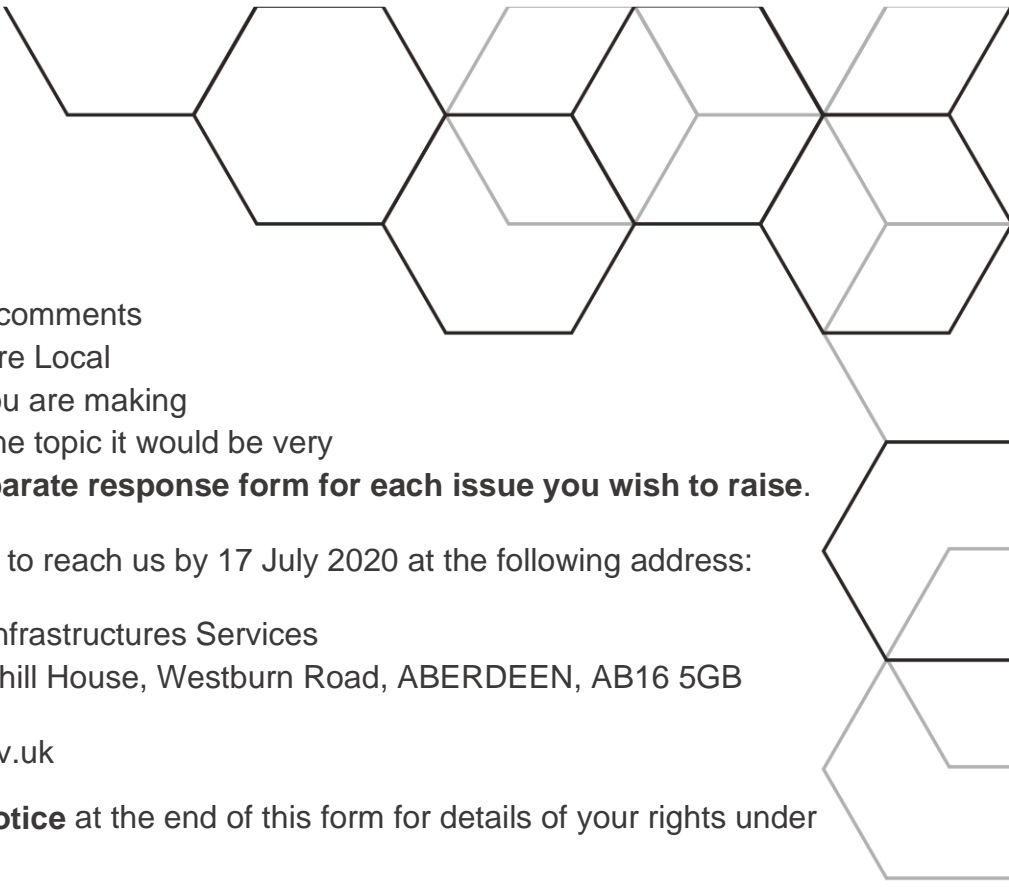

Reason for change:

I'm really concerned about the concentration of older people envisaged in this plan for several reasons:

- Generating a concentration of older people is not good for intergeneration relationships, it will lead to an "us and them" mentality. It is far better to have a good mix of old and young in the general population.
- I don't see any provision for even basic retail, somewhere to buy a paper or a bottle of milk. This will generate a high dependency on the use of private cars when the general strategy should be to discourage the use of cars.
- There no provision for a doctor's surgery, and an influx of older people will fall on the already overloaded Banchory practice.
- I see no sign of any increase in facilities at Inchmarlo House, which I know from personal experience, my mother who was in Inchmarlo House after stroke, and my in-laws owned a house in West Field, currently struggles to cope with very limited facilities.
- Finally, I don't think that a large development to the west of Banchory is a very smart move, it is separate and doesn't really have much chance of becoming integrated with Banchory. It really seems to be driven by property development rather than good urban planning.

I made all these points in my original submission, and I'm really disappointed that more common sense hasn't been used in the development of the local plan. It's more likely to be a source of future intractable problems.
