

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Proposal for development at R2 Torphins, cemetery extension. We would like to propose that alternative site immediately behind R1 is utilised as this does not affect any residential properties and is closer to the village hall which is utilised by families for funeral teas and more accessible on foot from the cemetery car park.

Reason for change:

We are resident [REDACTED] in front of the proposed extension. We have lived at the property for 13 years and enjoyed the views across open countryside. The building of a surrounding wall similar to that in place around the current cemetery around the cemetery extension would remove this view completely from our property and devalue our property. On the other hand a lack of suitable height wall would result in invasion of our privacy especially during funeral services which could be conducted only metres away from our back garden. This could also result in lack of dignity and respect for the bereaved families if children are playing outside. We feel the site immediately behind the village hall and behind R1 would be more appropriate as this doesn't affect any current residential properties and is more convenient for the current car park and for families, in particular those with reduce mobility to attend funeral teas which are frequently held in the village hall.
