

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Second, regarding Alford OP1 there is no watercourse in the remaining council holding. The watercourse on the western boundary of the whole site is now within Alford and District Men's Shed ownership. It is an ephemeral stream wholly unsuited to re-engineering. The previously stated issues regarding the unsuitability of the site for any use requiring significant commercial vehicle traffic is acknowledged, but it should be pointed out that the council previously closed Greystone Road permanently to the new Community Campus and nearby housing development based on traffic volume and pinch-points on Greystone Road. The pinch-points remain and any access to the site from School Road/Murray Terrace would worsen this problem. Road traffic engineers have made a judgement about the unsuitability of Greystone Road for high volumes of traffic and this judgement needs to be respected.

Reason for change:

Point 2.

There is misinformation about the location and ownership of the stream. It actually sits between the owner of a ransom strip on the west of OP1 and another ransom strip on the park side of the stream. In neither case are the council, the sellers of the site at OP1, the owners of that land. There is potential flood risk on that land which has already been exacerbated by the building of the community campus which has diverted the water on c 10 hectares of land designated MRO43 into that stream, Any increase in soil sealing in MRO 43 would worsen the flood risk significantly unless effective SUDS were developed, as would any proposed development in MRO42, most of which drains to the north rather than into the Kingsford Burn (another flood risk site as it is culverted under the centre of the community).

Second, the planning system seems not to be acknowledging prior decisions of road traffic engineers with regard to the suitability of Greystone Road for higher volumes of traffic and in particular commercial vehicle use. Communications between the silos of local government might be recommended and safety given due consideration.

Third, the centrality of the site at OP1 makes it a key site for the community and community uses. A more structured engagement with the local community to try to explore use options may be better for local development than simply trying to offload the site to realise some return to the council.
