

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



YOUR COMMENTS

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Third, I would like to question the removal of part of the proposed core path network (CPN) in woodland adjacent to the pleasure park and school in Alford. The path in question running from the Pleasure Park to the old military road near Gallow Hill is subject to a high level of use and links to the Gallow Hill-Wellhead part of the CPN. In the Covid shutdown I have observed massive increases in the use of footpaths and having spoken to users they have indicated a strong desire to continue to make good use of them when shutdown is over. In other parts of Alford and its surrounding there are further opportunities to extend the CPN. Covid has provided people with an opportunity to get to know their local communities and a denser CPN with clover leaf loops and links to the Gordon Way and other hilltop viewpoints is strongly recommended. The Vale of Alford would be an excellent venue for a project with Paths for All to enhance access networks for walking, cycling and riding.

Reason for change:

Point 3 This is raised more as a hope that the opportunity of enhanced access and use of local carbon neutral leisure would be enhanced by a more effective CPN, when the proposal to remove part of the proposed CPN actually weakens it.
