

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

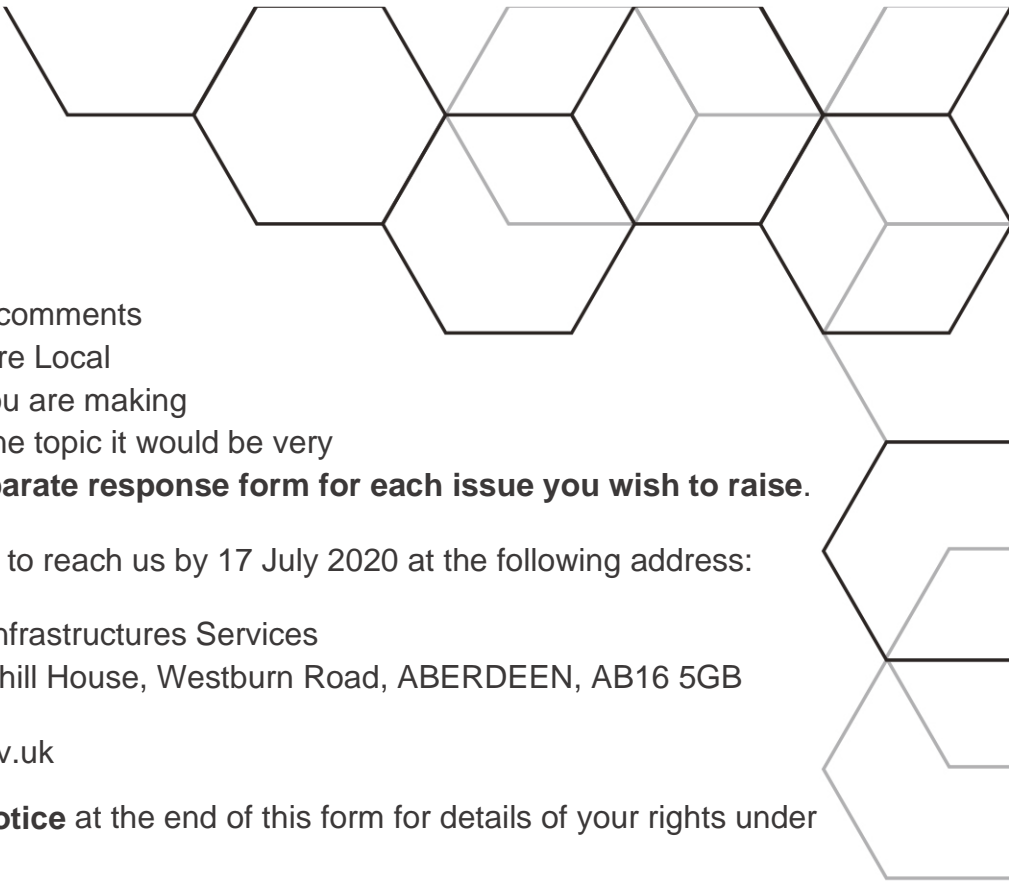

Proposal for development at Site OP1, Huntly – Planning reference MR002

Reason for change:

Having searched the LDP for information in relation to the above Proposal with some difficulty we have considered the letter sent, information in LDP in relation to Huntly and the Planning Bid MR002 and wish the following points to be considered:

Letter to Homeowners affected – this refers to OP1 and only through searching the information online it relates to BUS1 – there has to date been no communication of change of uses from industrial to housing which is a concern, Also the letter has not been sent to residents potentially affected by the access from Deveron Road end within Deveron Park and also Scott Drive which is a concern and requires further investigation and consultation.

MR002 bid – we are concerned that within the letter it communicates 50 homes to be built on the site however within MR002 there is very little concrete information. Again we raise concern about no notification of change of use from business to industrial within the planning history. With regards to Infrastructure and Drainage where we live within Deveron Park there have already been repairs to the drains over the last 2 years due the Towns system not coping with the current housing capacity and also the pumping station adjacent to Tesco Filling Station was blocked over the 2019 Festive period so any additional housing will increase already significant pressure.

Facilities – Since the development of both Milton and Deveron Park housing schemes the Town has seen no increase in Education and Health Provision – apart from the construction of the new Nursery School building which has been delayed due to the current COVID 19 Pandemic. This was also part the terms of both previous applications so we wish to raise concerns that the same thing will be allowed by Aberdeenshire Council to happen again.

Within Huntly we have continued to see a reduction in the town shops since the Tesco / Asda developments and also the employment opportunities continue to dwindle – Pipeline Technique relocating to Aberdeen being the most recent..

We would also question as to why another are is required for affordable housing within the Town of Huntly when there is also another site which is already for sale and many

council housing stock within the town itself is sitting vacant with no tenants – it would seem only sensible and reasonable to make use of what stock is already there before considering developing other areas.

We would also like to comment that the LDP should be delayed due to the COVID19 Pandemic as surely something so significant should be consulted on properly not Virtually as this restricts the ability for people to fully engage. I would also like to comment that I have tried to contact Planning by phone – no reply and the Chat facility not able to use .
