

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Omit OP3 Belhelvie

**Reason for change:**

- The additional 49 houses with a loop road will add too much traffic to the existing Cairntack Road entrance. There are a lot of young children living on the road and the poor sight lines on the road will add risk to living in the area.
- Belhelvie needs greater infrastructure before any additional houses provided. Corner shop, pavement connectivity to Potterton and Balmedie all need provided before any additional houses brought to the area.
- Belhelvie is a reserved hamlet with a mix of larger to smaller properties. If and additional 49 houses are built they are likely to be low cost affordable housing not in keeping with the housing stock already built this could have a negative effect on the hamlet.
