

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

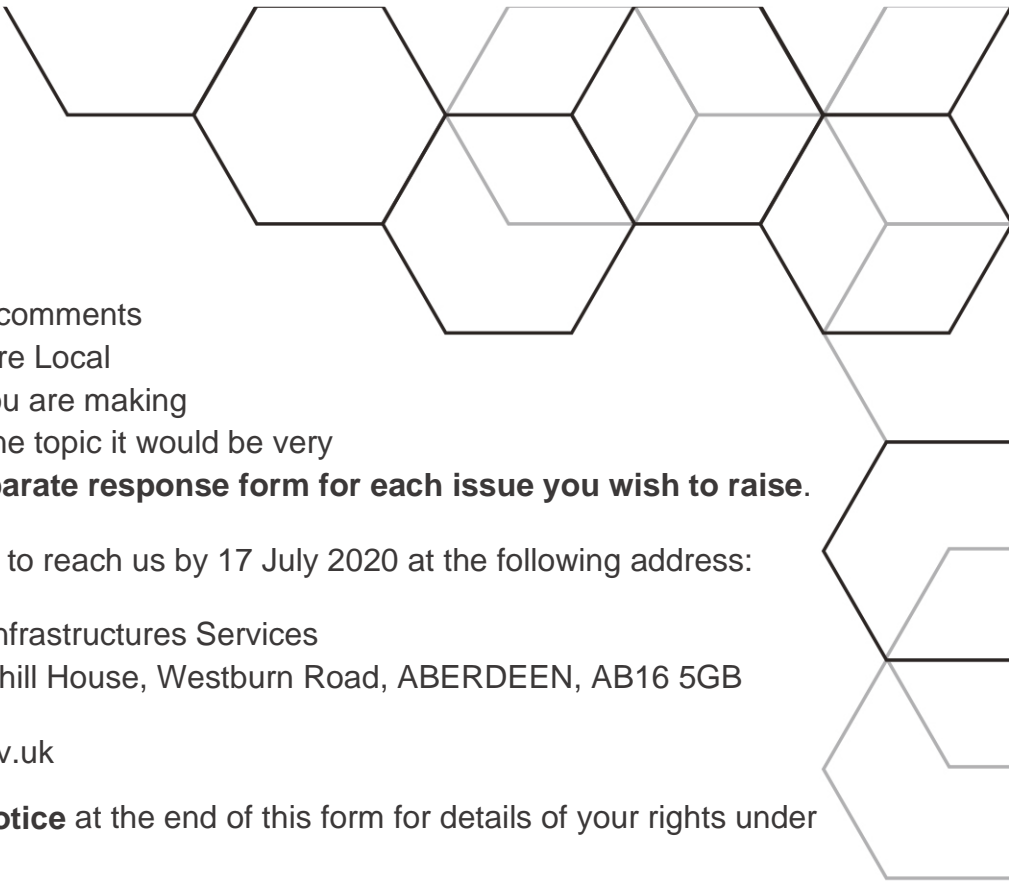

Strategic Environmental Assessment of new allocated sites and alternative bid sites – Kincardine & Mearns. Bids KN057, KN058 and KN109

Reason for change:

These sites should not be allocated for the following reasons-

1. They form part of a valuable and ever diminishing green belt area.
2. There would be a huge detrimental impact on the local environment leading to a loss of identity and sense of place that is Portlethen.
3. There would be a significant impact on the air quality in the surrounding area.
4. The peat soil would be severely affected as would the habitats for a wide range of local flora and fauna.
5. The land slopes significantly and is subject to major drainage issues.
6. The current primary education facilities are operating at over capacity or near capacity and even with the extension to Hillside Primary School, there would still not be enough capacity with other nearby developments currently taking place.
7. Previous promises from developers about the provision of education facilities have proved to be far from satisfactory.
8. The medical facilities at Portlethen Medical Centre could not cater for such an increase in patient numbers.
9. The effect on the local road infrastructure would be such that major road improvements would be required to cater for the enormous increase in traffic that would be generated.
