As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Page 136 Rothienorman

Water :

1. "There is available capacity at Rothienorman WWTW".

Change to "There is insufficient capacity at Rothienorman WWTW, which should be addressed prior to any development" and

2. "Whilst the proposed development is in close proximity to a watercourse, there would be no impacts arising as a result"

Change to "The proposed development is in close proximity to a watercourse, whilst there are likely to be no impacts arising for the proposed development itself, the proposed development may well have an impact on other properties closer to and downstream on the water course, which have already suffered flooding due to excess run off."

Reason for change:

Aberdeenshire Council's own document "final issues and actions – Formartine" available within the LDP archive website states in Issue 84:

2. Issues, General states:

"There are major flooding issues within the settlement that will need to be addressed prior to new development" – as a resident, I can verify this statement. It needs to be considered.

"SEPA understands there is limited capacity at Rothienorman Waste Water Treatment Plant so a developer will be required to initiate a growth project with Scottish Water in order to develop the full site" – This issues has been cited many times, nothing has been done to date therefore it needs to be included in the LDP

3. Actions states:

"Cognisance does need to be drawn to flooding and drainage issues however, with this referenced and solutions required in any allocations" – There is no reference in the LDP, this action has been missed.

In addition, your own "Main Issues Report" notes that for Rothienorman: ".....waste water capacity are current constraints that would require to be resolved before the site could come forward but do not prohibit the site from being identified as a preferred option" – Therefore this needs to be noted for relevant proposals within the LDP "Waste water treatment capacity is currently constrained." - Therefore, this needs to be noted for relevant proposals within the LDP

The WWTW and more especially the village flooding issues are well documented, are known to the council and are highlighted for every planning development in the village and cannot be ignored in the development of the LDP. A key point must the flooding impact to the surrounding area caused or contributed to by new developments. I feel strongly that a good degree of existing flooding issues are caused by developers only safeguarding their own site with no overview of the holistic impact to the area.

Once these issues are resolved it will be great to see development, especially affordable development in the area.
