

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

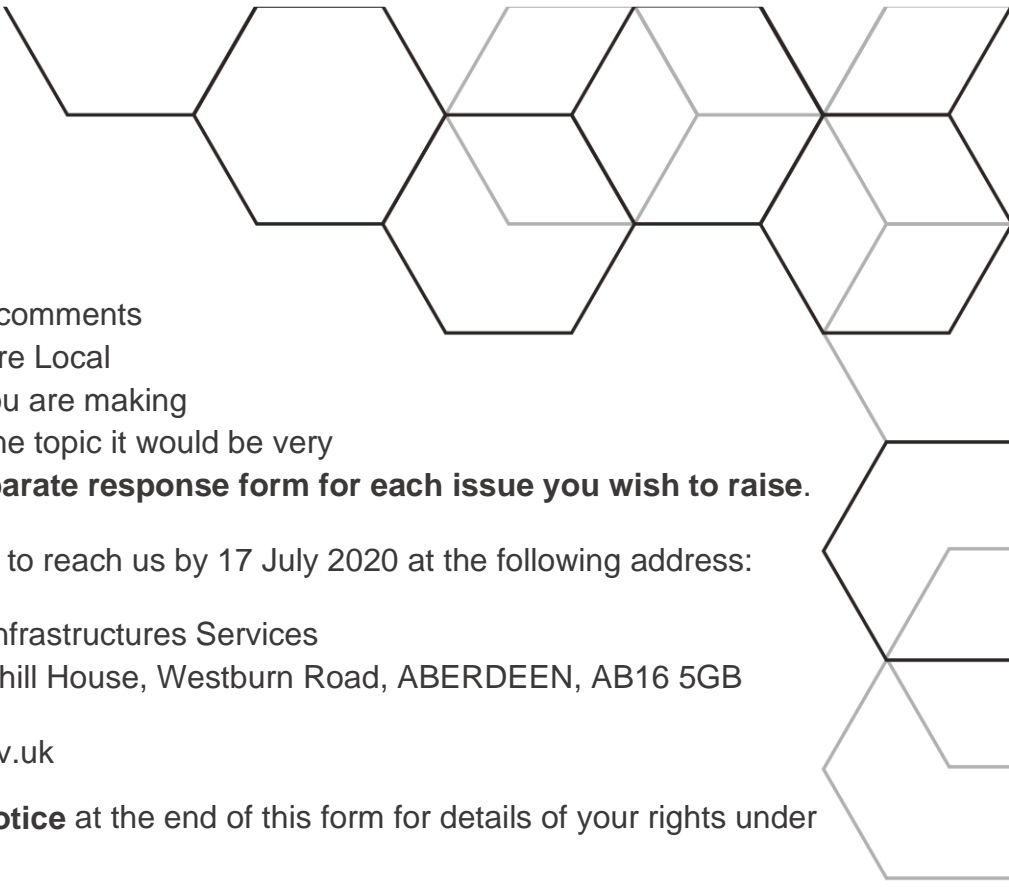

# YOUR COMMENTS

Removal of proposal OP1 "Land South of Earnsheugh Terrace" from APPENDIX 7E SETTLEMENT STATEMENTS KINCARDINE AND MEARNIS

**Reason for change:**

We believe the settlement OP1 should be removed from the plan because it contradicts several of the principles of the plan (i.e., National Outcome Section 3.6, Regional Vision sections 3.8, 4.4, 4.7, 4.8 and 5.1).

The proposed development is sited such that it will negatively impact our built and natural heritage (NOS 3.6, RV 3.8). Findon is a historic village that is a mix of fishing cottages, crofts and coastguard houses and is located within the SE Aberdeenshire Coast Special Landscape Area. Although the development plan suggests that the impact of the development will be mitigated by careful design, we don't believe it will be possible to do that; converting an agricultural field into 11 houses will have a significant visual impact on the village, altering the density and distribution of houses, making the village more like an estate than an irregularly developed historic village. Also the development would remove a green space that is embedded in the village that allows views of the Coast SLA from Earnsheugh Terrace and Old Inn Road. The development sits about 80 m from Findon Moor (SSSI) and would be visible from the Moor and the coastal walk that connects Findon to Portlethen village.

The proposed development OP1 brings no benefits to the village, contradicting RV section 4.4 which states that developments must improve the natural and built environment. The inclusion of green space within the plan will not enhance the green network – 60% of the site will be occupied by paved roads and buildings which represents a significant loss of green space in the village.

We don't believe this is the "right development in the right place" (section 4.8). Firstly, this is due to the impact on the natural and built environment but also because of the road infrastructure that serves the village includes single track roads, two blind corners, and steep hills. There already is a traffic problem on the roads in and out of the village during commuting hours; the additional vehicles associated with 11 new houses and the construction work would make these problems worse. Secondly, the development is situated on productive agricultural land that is typically used for grazing. The plan (section 5.1) emphasises that the priority is to build on brownfield sites and lands with low productivity – this location does not meet that requirement.

In summary, we believe that the proposed development OP1 should be removed from the local plan as it is contradictory to the spirit and intention of the development plan.
