

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

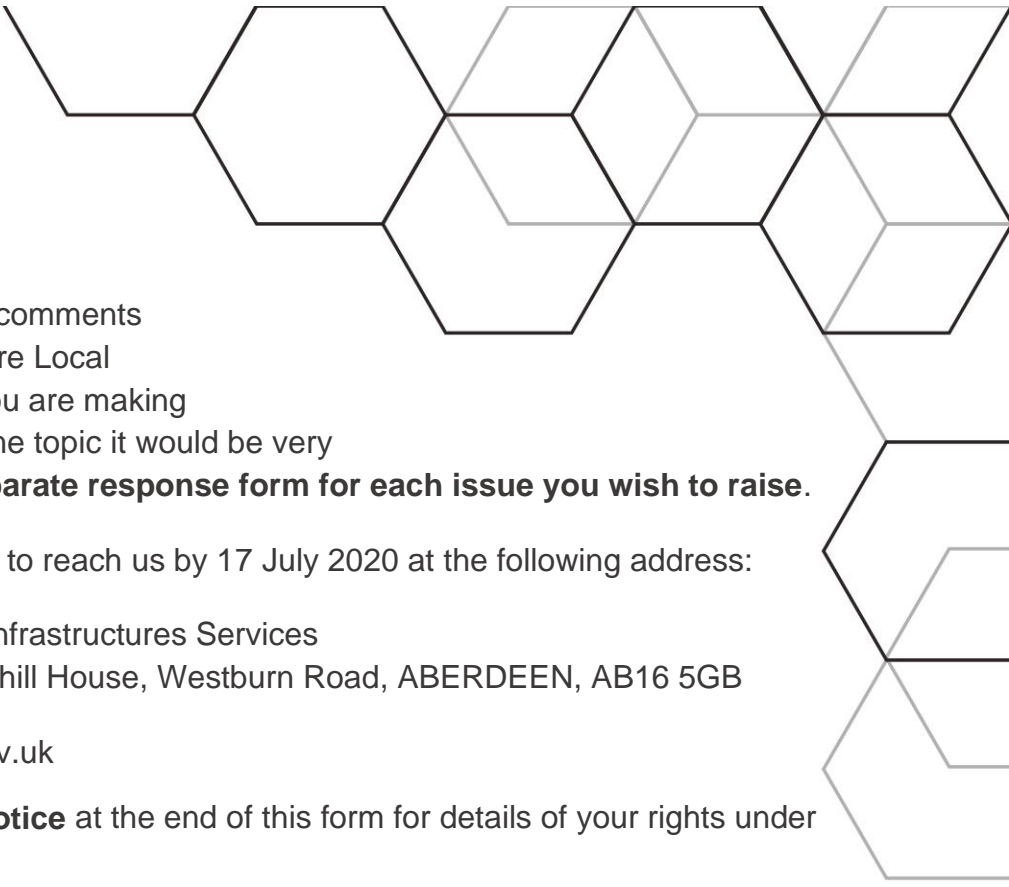

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Revise the text of Policy R2 Development Proposals Elsewhere in the Countryside to make it clear that a criteria based approach is to be taken to the small scale organic growth of settlements in rural areas outwith the green belt and coastal zone.

## Reason for change:

Under Policy R2 Development Proposals Elsewhere in the Countryside of the Proposed Local Development Plan (PLDP), it is stated that small-scale growth of identified settlements may be permitted where a particular need for development has been established, and that a list of identified settlements and the number of homes that could be permitted by way of expansion to each is to be contained in Planning Advice, Organic Growth of Settlements.

This follows the recommendation, as set out in the *Issues and Actions Paper – Policies and Introduction* and agreed by the Infrastructure Services Committee at its meeting of 3 October 2019, that a criteria based approach should be taken to small scale organic growth of settlements, rather than having this apply to a limited list of settlements only. As also set out in the *Issues and Actions Paper*, it was considered that this approach would allow for greater flexibility and achieve the policy principle of Scottish Planning Policy to direct development to the right place through promoting development within or adjacent to settlements, particularly in accessible and pressured rural areas. Additionally, by not including a list of 'identified settlements' as part of the Local Development Plan (LDP), it was envisaged that this would allow for circumstances relevant to individual proposals at the time of submission to be considered, rather than be restricted to a list that was prepared prior to adoption of the LDP.

Following this, the text in the PLDP includes the criteria recommended in the *Issues and Actions Paper*. However, it also states that a list of identified settlements and the number of homes that could be permitted through the Policy is to be contained in Planning Advice, Organic Growth of Settlements, contrary to the decision that the criteria based approach should replace the approach of providing a list of identified settlements.

It is accordingly submitted that the reference to there being a list of identified settlements contained in Planning Advice should be removed from Policy R2, and this reworded to

make it clear that proposals for the organic growth of any settlement will be assessed following the criteria based approach set out in the Policy.

Related to this, it is recognised that it is necessary to determine how a settlement is defined for the purpose of this approach, and it is considered that the approach set out in the Issues and Actions Paper is an appropriate one to take, i.e. that settlements should have a recognised boundary/built up area, serve a residential function, feature urban characteristics including street lighting and a reduced speed limit, have at least 15 residential address points and a facility as listed in the Rural Facilities Monitoring Report published by the Council's Planning Information and Delivery Team, and that organic growth should focus on settlements with between 16 and 99 residential address points.
