As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

Torphins Community Council wishes to record its pleasure and thanks that the changes proposed by TCC and the community during the process of developing the LDP have been incorporated into the final Torphins Settlement Plan by limiting the housing development to allocated site OP1. This is a reasonable allocation of housing for adequate provision of suitable housing without dramatically changing the character of the village, and any other potential developments would be strongly opposed.

Community facilities include the Learney Hall, which is in need of modernisation and refurbishment, including the kitchen and toilets, which are well below current standards.

Sports and recreation facilities include the Torphins Park where the football pitch still requires drainage improvements to enable the local team to play there, and the pavilion is in need of refurbishment, which will be facilitated by a playing pitch that enables the local team to use the facilities.
