

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. OP1, OP2 & OP3 should all be cancelled & suspended until the items listed below have been addressed.

## Reason for change:

The local roads are not suitable for an additional 104 homes. Cairn View has **33 properties** where the proposed access road for OP2 & OP3 is.

OP2 & OP3: a "loop road" from Cairntack through to Cairn View would not be possible, the road system is already full with cars parked on pavements at Cairn View impeding access to the properties numbered 32 – 36, two further developments with a total of 90 homes would make access impossible. Being a "loop road" this would also make the "loop" a rat-run, thereby making it dangerous for children & pedestrians who already have to walk on the narrow road due to cars parked on pavements.

Bus services: The village bus service is not sufficient for the current properties in Belhelvie & thereby would not be sufficient for any further properties.

Amenities: There are no shops in Belhelvie, where will people shop? The nearest shopping facility is in Balmedie, there are no pavements & or cycle routes from Belhelvie to Balmedie, thereby forcing people to use cars (once again no bus service from Belhelvie to Balmedie).

Services: What arrangements are there for the sewage & water supply services. Increasing the housing by 300% will not be possible with the current systems.
