

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

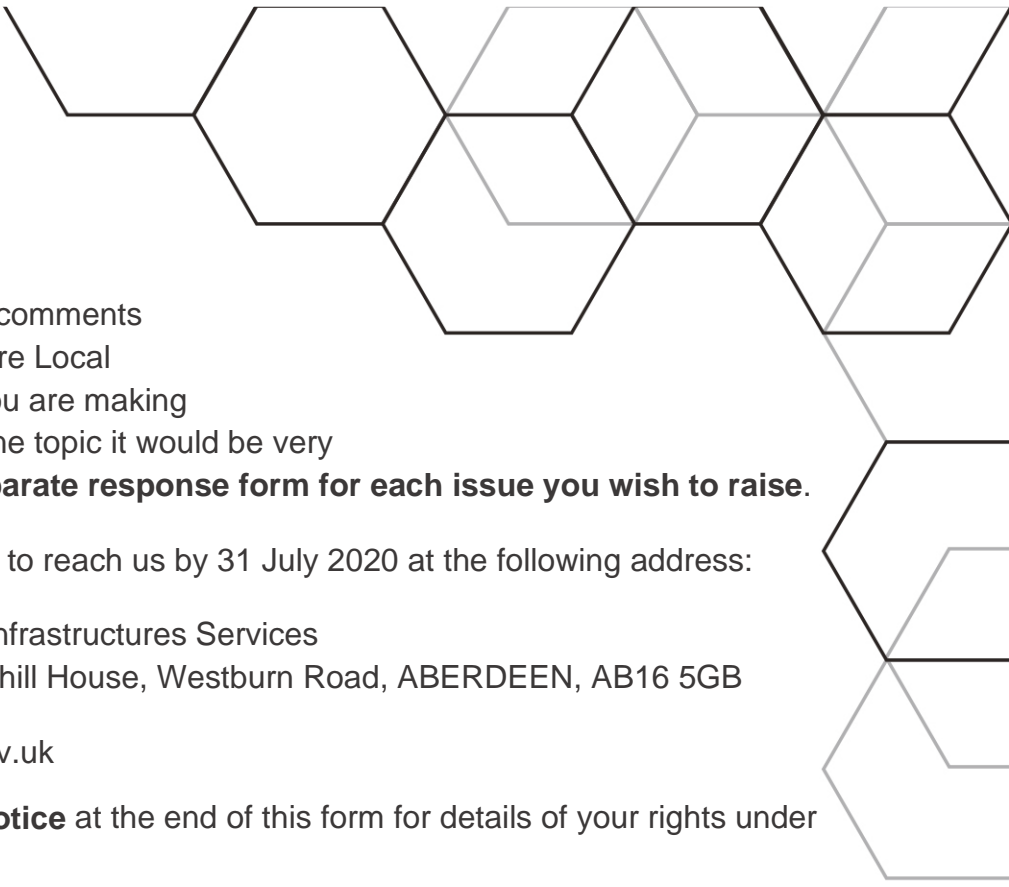

Newmachar Settlement Plan
Page 609 R1 – For the development of a recreational area

Reason for change:

The area marked R1 is the existing boundary of Charles Gordon Park and Requisite Park which are already used by Newmachar Football Club, thus meaning that there is actually no provision for any additional football pitches marked on the plan contrary to what has been written in the Vision paragraph stating 'There is a desire within the local community for the development of additional pitch(es) to meet the demand of a number of teams associated with the settlement' and also the Sports and Recreation facilities where it states 'All residential development may be required to contribute to indoor and outdoor sports and learning facilities in Newmachar or towards facilities in the wider catchment area based elsewhere. These may be identified in the Community Plan or relevant Community Action Plan. If not provided on site, open space contributions should include three sports pitches and allotments'

In OPS1 a previous planning application contained in the Masterplan for Corsedduick area the following (shown below) had been within this report until Stage 3 when it was removed and replaced with a green space area, now it appears that this green space area has been completely removed in the Local Plan and been replaced with solely Housing in OPS1. This area would be perfect for the additional pitches as Newmachar United teams could utilise the current facilities or look at adding additional portable changing rooms and additional parking areas so that the Club could cater for and allow full access to football for various age groups meaning the Club would strengthen their reputation within the village and provide better opportunities/facilities to allow the Club to continue to grow in line with the increased housing developments that are planned for the village.



I would be recommending the reintroduction of the area previously mapped out for additional football pitches (shown above) so that the Local Plan can become a truthful document showing an area for additional pitches, whereas currently the plan is factually inaccurate and misleading in respect of providing additional pitches in the village.
