

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

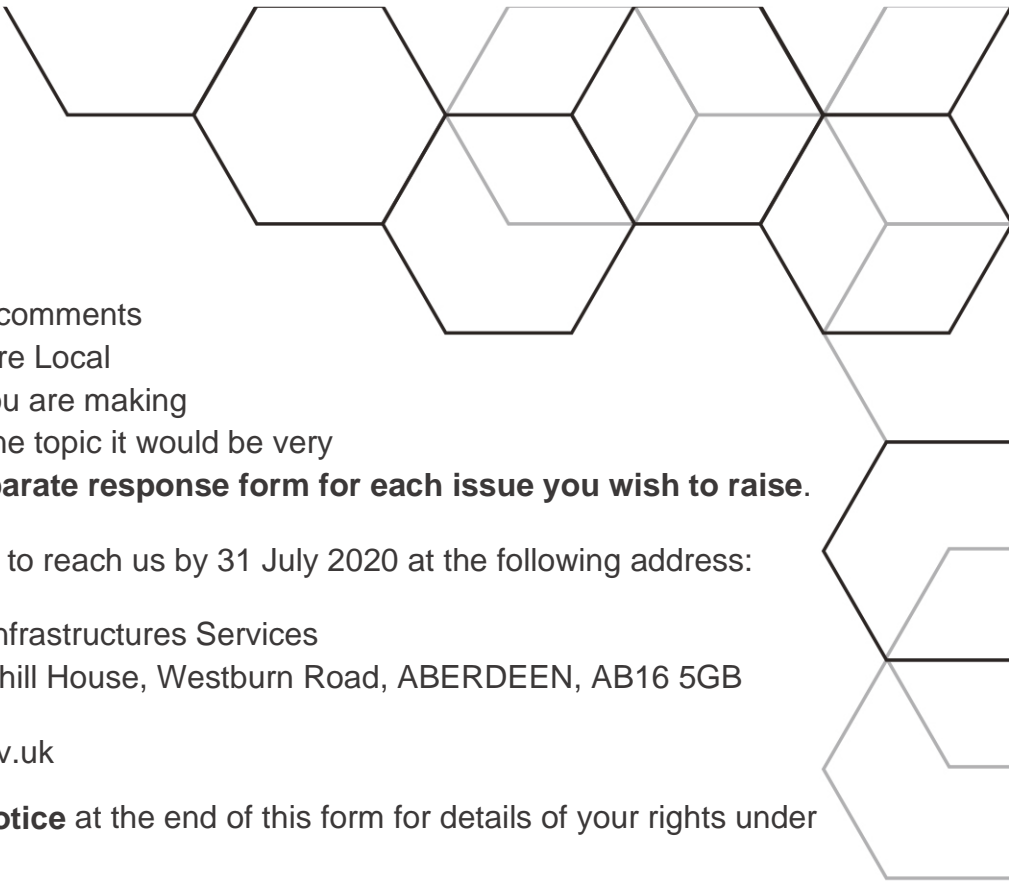

# YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

It is noted in the Vision statement of and Sports and Recreation sections of the document that Newmachar is in need of additional facilities to cater for the local club and in fact the map shows an area marked as R1 has been earmarked for such a development. R1 however is the perimeter of the existing sports facility at Charlie Gordon Park and Reisque park used by the club. Therefore, the map is factually inaccurate as this is not providing additional land for sports and recreation.

**Reason for change:**

As a continually growing community with plans for further additional houses the sports facilities are wholly inadequate and despite an apparent desire to resolve this by providing additional sports and recreation space this is not being undertaken under the current plan. It is therefore a requirement that additional land be earmarked to allow the local club to remain local and continue to grow from its current 12 teams, 150 members who are struggling with only one full size grass pitch and one rented seven a side pitch. If additional facilities are not provided the club will have to restrict membership numbers or alternatively move out with the locality to remain operational, neither action being palatable for a community minded organisation.
