

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

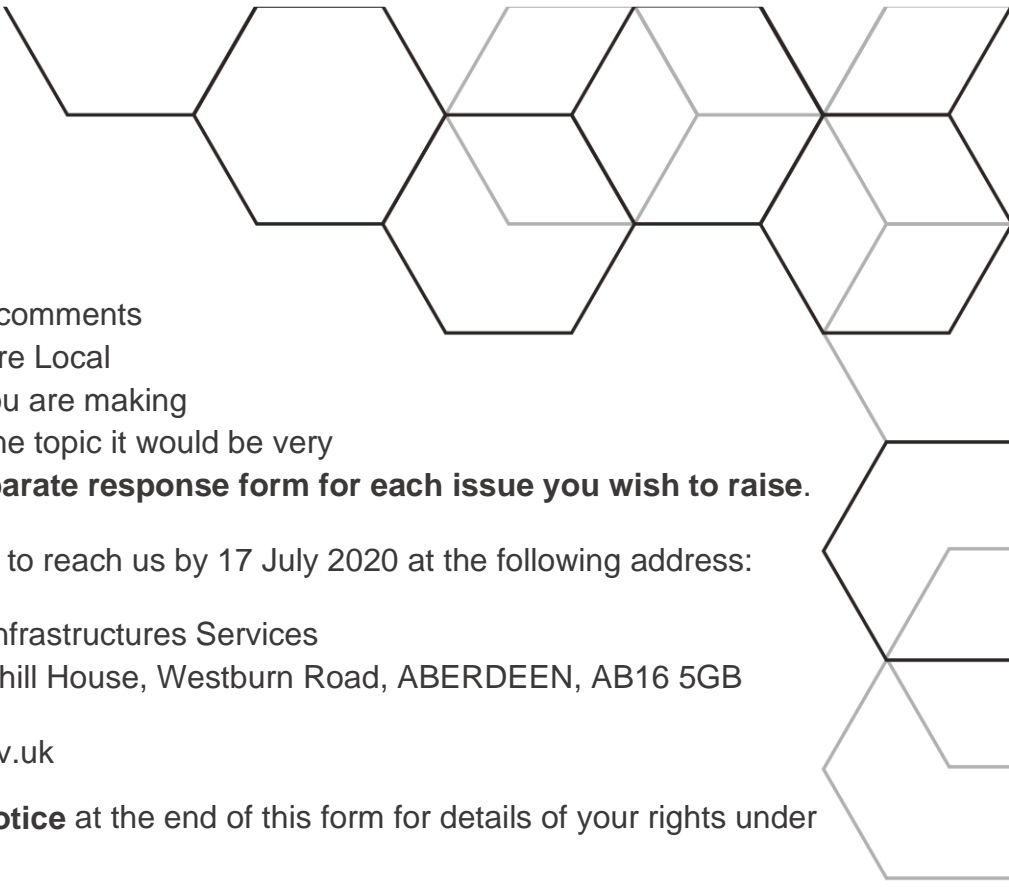

OP5: Land South of Gardenston Street - Allocation: 11 homes

**Reason for change:**

The proposal is absurd, the fact that there already limited vehicular access on and around Gardenston Street and West Burnside both dead ends, will cause even further issues in relation to pedestrian safety as well as vehicle congestion.

A proposed new entrance from the High Street will add to further safety and congestion to an already busy thoroughfare which will get worse when the welcomed A90 reconfiguration happens.

The area gives a traditional rural setting / vista when entering Laurencekirk from the south, any change to this would be detrimental to both the overall landscape as well as outlook especially when the proposed A90 changes take place.

Any proposed construction work will have an adverse consequence in a settled thriving wildlife environment around **Gaugers Burn** which includes badgers, bats, foxes, red squirrels and deer as well as numerous birds such as wood peckers (various species), red kites, robin's, owls and buzzards.

Additional light and noise pollution will have a major impact on the established wildlife environment mentioned above as well as the detrimental effect on encouraging new species to the area.

Gaugers Burn has long been established, we have concerns that any further water run off from man made formations (driveways etc) with impact on the ecology and surrounding environment, adding further pollution and contamination into an already strained watercourse.
