

## RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



I took it upon a small Facebook based survey to see if anyone in the area may be interested in allotments, the feedback was massive. Very quickly I had in excess of 40 people interested in a plot.

I approached our local councillor, and held a meeting at the community hall of which we had about 25 persons interested in a site.

We have formed a committee with some fairly simple goals;

- Promote and encourage the cultivation and enjoyment of the allotments
- Promote and develop gardening skills
- Promote the use of allotments within the local community for people of all backgrounds and abilities
- To provide equal opportunities to all Members without discrimination on any grounds
- Promote and encourage the management of green waste and materials recycling

The simple idea was to bring people together and provide a safe local site to grow vegetables.

Ideally the site would be walking distance to everyone being within the village, though some space for parking would be required for those who are elderly etc.

The allotments would become a haven for wildlife with a larger view to have a community orchard for all to enjoy.

The land proposed by the council in an underused area being on a slope, it is south facing and lends itself perfectly to growing with a quiet peaceful view over Blackburn.

I hope that this site can be approved for us all to enjoy
