

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

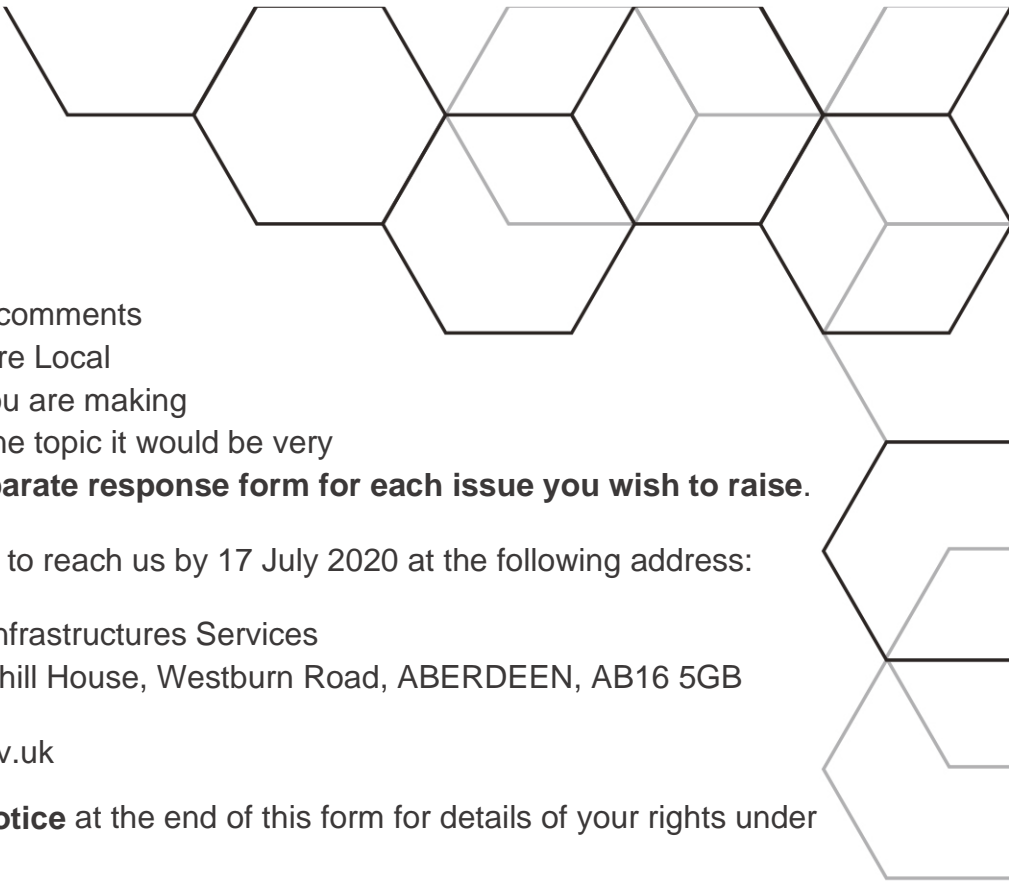

App7d – Newmachar – area R1

Reason for change:

The identified area for a recreational area has been in the most part a football pitch (Charlie's Park) for over 50 years, the smaller area known locally as risqué park is privately owned by a householder who allows Newmachar Utd kids teams to play and train on this grass area. How these areas could be classed as a 'new' area to be developed for recreational use is beyond me.

Over the past 30 years Newmachar has more than grown to more than 3 times its' then size, in that period of time developers and landowners have made a lot of money whilst the promise of land for football pitches has always been made but sadly nothing has ever come to fruition as it's never been cast into planning approvals.

All too often planning gain monies has returned to the public sector, GP and school provision never to be seen locally.

Could I suggest that on this occasion that the sum of £1,000 per developed housing plot be passed to Newmachar United FC to allow the club to secure additional land and develop pitches for the free use of the club and the local community.

As a child I played football at Charlie's Park for fun and for Newmachar Primary School, my kids play there now as do more than 100 other kids but additional pitches are badly needed to allow them to play their matches on Sundays and train on week nights.

It's about time the council required developers and landowners to invest back into the communities that they profit so much from.
