

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Reason for change:

I have 3 major issues with these development...

1The burn that runs down the side of my property cannot handle the water being already diverted into it, This was highlighted significantly when the Ardinn development across the road had the excess rainwater plumbed into the burn approx. 10 yrs ago Since then my back garden has flooded three time during flash flood storms (see pictures attached)



2)The water flowing down the same burn has eroded into my garden twice and I have had to fight the council/SEPA both times to get the burn shored up. On both occasion's the default was to refuse any responsibility and it's only because I have a sewer pipe running down my garden which became at risk did I manage to get some remedies. I had to get councillors involved. (see pictured attached of one of the two repairs)



3)The elevation of the field involved for the new housing is significantly higher than my house elevation and I suggest any new housing would impose terribly on my property and leave us with no privacy or light..
