# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

\*1 Section 4 Sub Section 4.7 "To make efficient use of the transport network, reduce the need to travel and promote walking, cycling and public transport."

\*2 Section 5 Sub section 5.3 "Housing projections for the period of the Plan have been informed by the robust and credible Aberdeen City and Aberdeenshire Housing Need and Demand Assessment 2017 as the context for development over time.

\*3 Section 9 Sub section P1.1 Layout, Siting and Design

#### Reason for change:

\*1 There is no public transport of note within Echt and other areas are poor when it comes to inter-area transportation. There is one bus in the morning into Westhill / Aberdeen and again a single bus back into the village in the evening. Nothing at all at the weekends. There are no cycle paths and it is not safe or within reason to walk anywhere There are no facilities to support the additional population. This will only increase the need to travel for both adults and children.

It has already been noted that people are becoming increasingly reliant on travelling by car as the public services and transportation are poor.

\*2 This may be outdated and not in consideration with what has, is and will happen to the city of Aberdeen and the Shire as a result of the decline of the Oil and Gas Industry within area and worldwide, this being one of the largest contributors to employment and housing in the area. There are already local sites in progress (Dunecht) which are not selling as there is not the demand in the area. The longer term future of the city and shire requires to be considered before there are too many houses for too few people which will ultimately effect to overall economy negatively.

\*3 The area in question for Echt (OP1) has for a considerable number of years repeatedly flooded. Previous instances incurred flooding of the existing Phase 2 Development which is on the boundary of this proposed OP1 site. The flooding also effects the neighbouring farmland and the designated rural path around the village making it unpassable. The flooding in the area will only increase with the addition of this proposed new development as there will be less open ground for the water to drain / disperse too. When was the area last subjected to a flooding assessment? With the addition of the new houses and the dramatic increase the flooding in tis area over the last few years this are area may need re-assessed and re-classified.
