

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The proposed allocation of development site OP1 (Land to the West of Park Village Hall) should be removed.

The site is identified in Appendix 7E , Settlement Statements , Kincardine & Mearns , page 722-723 ,Park

Reason for change:

The site has been included in a number of previous plans but has not come forward for development.

The failure to bring the site forward has frustrated the previous Plans housing targets through unused allocation. As the opportunity has not been taken to use this allocation over a protracted period, it should now be removed, as evidently it cannot be progressed.

The proposed allocation suggests a doubling in size of the Park settlement, which would fundamentally change the nature, and character of the settlement and represents gross overdevelopment.

The settlement of Park has changed very little since at least the mid-19th century and the proposal would do enormous damage to Parks Historic landscape. The proposed allocation would be damaging in relation to former Free church , which is undergoing redevelopment , and its setting within the landscape

There is no demonstrated requirement local requirement for housing in Park and no material evidence submitted as to how the proposal would enhance the village environment or community atmosphere. The suggestion of support for the local Park shop appears weak in the extreme as Park is located very close to Drumoak (walking Distance) and the shop serves this and a wider community.

The proposal appears to be contrary to a number of Policies outlined in the Local Development Pan and other support Planning Advice notes.

The prevailing organic Growth guidance suggests that 20% is a recognised maximum if development is permitted this scale would appear more appropriate.

Drumoak has provision for further new housing and is more able to absorb development due to its scale and facilities.
