We hope you are well? This is what was sent to you. I hope you can read this, this time.

I write in connection with the above planning application. I have examined the plans and I know the site well. I wish to object strongly to the development of these so called affordable houses in this location.

It has been evident that in these unprecedented times (COVID-19) we need as much green space as possible to allow for people to roam freely taking in the views for their mental health.

At present there are approximately 150 properties for sale in the Huntly area and numerous empty council properties.

The proposed siting of the development is particularly ill-considered: it is on a greenfield site used by many villagers for recreation and walking dogs, and building here would both diminish the striking view into the **Clashmach Hill** which is prominent from most angles from the Forest Way properties.

Also there are a lots wildlife on this site i.e. Deer, Rabbits, Birds etc.

The reasons for rejecting this development also included the inadequacy of a viable and safe access road from Steven road to even accommodate a small increase of traffic next to a pre-school/nursery, which would have a detrimental impact on children's safety when out on their walks.
