

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



R1 Cluny and Sauchen to remain as protected land for Aberdeenshire Local Development Plan 2021.

Reason for change:

We as a family strongly feel this is the wrong area for a community hub to be placed within Sauchen.

In the vision statement it is quoted that "the lack of community facilities or meeting spaces within Sauchen is an issue for the local community". You state that this is a "community aspiration". At present there have been meetings and a survey to look into this, but it states that everything is very much at the discussion stage. No results have been made public or any decisions of the outcome.

This area should remain protected, as it is at present. It is a much used and enjoyed public green space for the local community for walking, dog walking and children playing. It is in a settled residential area that has been in place for many years, and the green space supports local wildlife and flowers supports the biodiversity of the area. To place a building in this area would lose trees, wildflowers and a valued recreation area.

Due recently to coronavirus this area has become even more valued as a green open space for the local residents of Sauchen, when we have been unable to leave our close environment to enjoy other green spaces made this small area even more precious.

This area is unsuitable for a community hub. The access for this area is through established residential streets and one street has traffic calming bumps and both streets have limited parking. There would be no space available for a car park for a community hub in this area. If you built the community hub without car park cars would be forced to park in the turning areas and nearby streets causing congestion and difficulty manoeuvring in the streets. The amount of footfall brought to this area would increase, and the level of the noise from a community hub would change the environment for the residents in this area and cause a loss of privacy.

We bought this home within a rural village in the knowledge that this area was protected, and we would be able to enjoy the wildlife and it would be suitable for retired living.

Any change would adversely affect our quality of life and we therefore feel this should remain a protected area in the new development plan.
