

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



10 homes at former Archaeolink Site

This site should not be made available for housing development and should be removed from the plan.

Reason for change:

There is patently no requirement for additional housing on this scale in Oyne. This is clearly evident from the number of building plots in and around Oyne that have remained undeveloped for a number of years, including Site OP1 itself. There are also houses in and around Oyne that have been up for sale for a considerable length of time and have not sold.

This was the situation even before the repercussions of the Covid-19 pandemic and the latest slump in the oil price, initially triggered by a Russia/Saudi price war. Together, these two factors are going to severely damage the regional economy for years to come and suppress any need for new housing. The low oil price alone is forecast (by Oil and Gas UK) to result in up to 30,000 redundancies in the NE of Scotland.

It is time to face facts. There is not, and for the foreseeable future never will be, a necessity for this scale of housing development in Oyne. This threaten development is a blight on the heart of the village and should be removed from the area plan.

If the plan were to proceed regardless, the following restrictions must be imposed to minimise the environmental and visual impact on the village and to minimise disruption to Oyne residents.

1. The existing screen off mature trees around the perimeter of the site must not be cut down.
2. The design of the houses must be restricted to 1 ½ storey in keeping with other new houses in the village.
3. Access up to the top to Berryhill for walkers must be maintained at times, including during any construction.
4. The 10 homes must all be built in at the same time and not piecemeal over a number of years; the centre of the village must not become a perpetual building site.
5. Additional speed reduction/enforcement measures will need to be put in place. The current 30 mph general limit, and the episodic 20 mph limit in front of the school, are frequently violated.

6. The existing recycling facilities should be maintained within the site.
7. Installation of proper drainage must be a priority. Natural drainage is chronic due to the heavy clay soil.
8. The sale of the land should include an irrefutable and legally binding clause that the total number of new houses on the site can never exceed ten. This site must not be allowed to become a phased development with ten houses now, ten more a couple of years later and so on.
