

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

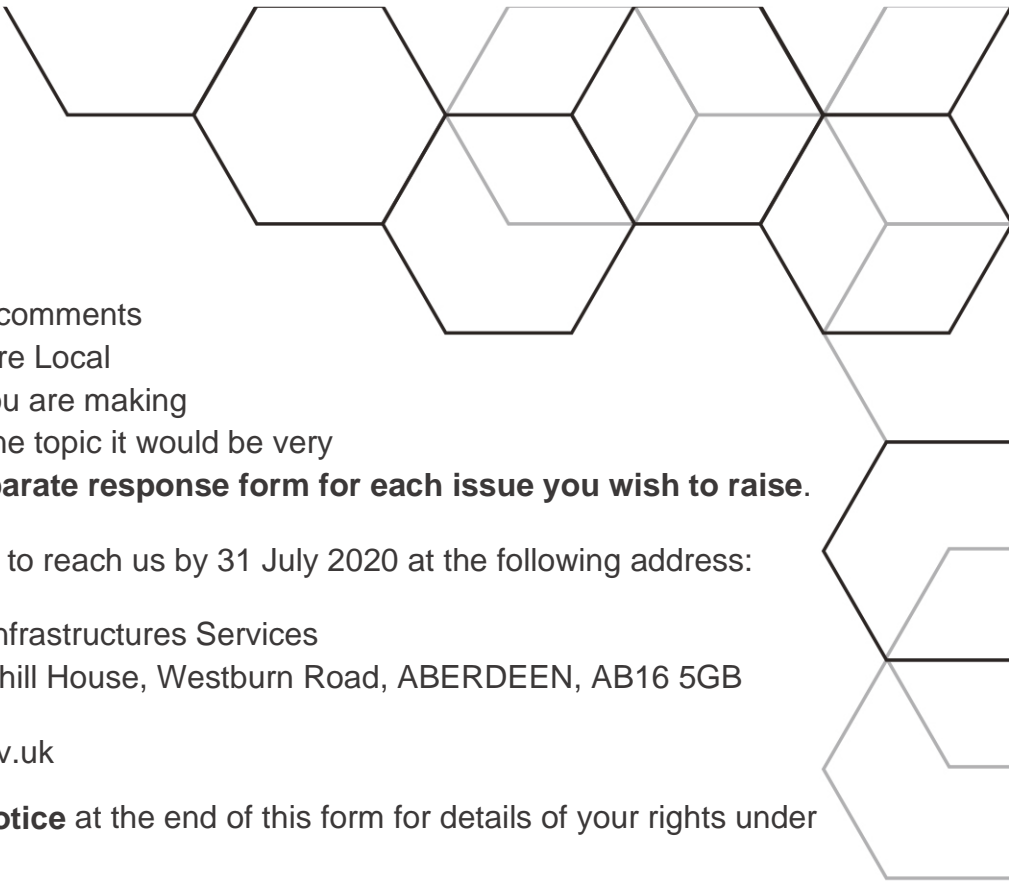

You ask what on the surface is a reasonable question What do I want to see changed I think the answer is equally simple the overall process.

Reason for change:

1: The process for a development such as this should have a more open approach which should cover not just developments that, in your view, affect me directly but any and all proposed developments that will affect the village as a whole.

2: Also the consulted parties should be the all the residents not just those who may have a border on any proposed development. Any development/s of this size doubling the size of the village and more than doubling the population is a matter for everyone.

3: A guarantee that the appropriate amenities that would go with a development/s of this magnitude would be provided at the outset of the project not an afterthought at the end or simply a provision with no commitment or funds in place to provide them, especially provision for schooling and transport infrastructure to alleviate the already stressed roads and increased volume .

4: Detailed consideration of the situation we the county and I mean, locally, Scotland and the UK as a whole face right now. We face a no deal Brexit which predictably will hurt our economy more than most. A massive downturn locally in our largest job provider the oil and gas industry, something that is unlikely to improve in the foreseeable future and with nothing to replace it. A region of Scotland which is seeing month on month the degradation of the housing market.

Not to mention a Global Pandemic which is causing the worst economic downturn the modern world has seen. Notwithstanding all of the above you want to more than double the size of a small village with no amenities to speak of currently and exacerbate the local economy by providing a few short term jobs leading to a further depressed housing market and the total ruin of the local landscape as it is now.

5: You are the custodians of our way of life and the landscape in which we live for the short time we are here. It is not good enough to say if a builder wants to build nice houses that its ok. There needs to be a market for the houses and clear benefit to the community [REDACTED]. Builders do just that build they have no interest in the long term effects to a fragile community or way of life in 10 years' time we will still have to live with what you decide now. You need to clearly show the benefits to everyone not just a bunch reasons why it not a bad thing why is it a good thing for EVERYONE ?
