

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Proposed Local Development Plan 2020 - Appendix 7d, pages 603 and 604 (Meikle Wartle). Area 'GR112'.

Reason for change:

1. Concerns are raised over the '12 Proposed' houses for this area as it has been previously made evident that Aberdeenshire Council planners allow the number of houses proposed in an area to be drastically increased. I reference previous LDP's where the current 'Earls Ree' development in Meikle Wartle initially proposed 12 houses and subsequently 21 were allowed to be built with the developer taking an extended duration to complete the pavements and landscaping at what seemed to be with no enforcement being applied by the council.

What is in place to ensure this doesn't happen again and that the areas designated for public open space are not then filled with houses?

2. Are there detailed plans available for this proposed development, including but not limited to following:
 - a. House types (plans and elevation drawings, size / layout etc)
 - b. Ground level details indicating elevations on which houses will be built in relation to existing roads / houses (the field in the South West corner of the plot is significantly lower than the rest of the field).
 - c. Arrangements / details for roads, pathways, fencing etc bordering the adjacent property (Kinshaldy). Is there a possibility to have input in the border layout (fence / hedge etc)
3. The proposed development is immediately adjacent to our property and will block the current open aspect we have to the East & north-east and will also limit the amount of natural light into our property with the main family/living area of our house being to the back (east & north facing) if houses are built immediately adjacent to us. This will be apparent if the houses are greater than 1.5 stories high or if a significantly large wooded area is to be planted with significantly tall trees.
4. When our house was built it was stipulated that houses in the village could not be any higher than 1.5 stories, however this stipulation seems to have been waived for some houses built in Earls Ree. Building any house over 1.5 story at this site would not only be detrimental to our outlook and light it would also look out of proportion and be detrimental to the aesthetics of the surrounding houses in this part of the village.

5. It is assumed that the planned houses will be 'family homes' and therefore a good number of new children will be in the village. Amenities and facilities for kids in the village is very poor and not to mention that the Rayne North School is near to or over capacity at the moment what are the plans for upgrading the school?
6. Footpaths within and around the immediate area are very limited, particularly on the dark narrow country roads. This issue is more apparent when you have children that want to make their own way to primary school on bikes or walking. It is noted that this is contained as part of the villages 'Vision' however this should be looked at in more detail by the council.
