

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Section 8, paragraph H5.3. The Gypsy/Traveller site proposed for Blackdog to be relocated due to lack of access to employment, education and other community infrastructure in the immediate area.

**Reason for change:**

The Gypsy/Traveller site is included within the Proposed Local Development Plan, April 2020, Appendix 7c, page 407, OP1.

100% of responses to the Blackdog Masterplan consultation and all those that attended the consultation event objected to the Gypsy/Traveller site being located at Blackdog. There have been no amendments to the plan following this consultation.

Blackdog village does not have access to employment, education or other community infrastructure at present, although this has been promised on multiple occasions, therefore the traveller site in Blackdog would not meet the requirement of Section 8, Paragraph H5.3. The site should be moved to a location which has these facilities.

Currently there is no local provision for shopping, education, medical, police or fire facilities in Blackdog. The residents must travel to Bridge of Don, Balmedie or Ellon to access these services.

Blackdog also has limited public transport access with no access from the village centre and a reduced schedule for buses stopping on the bypass.

The access to Blackdog from the bypass has also seen multiple accidents on the roundabout with vehicles crashing through barriers.
