

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The settlement boundary of St Cyrus (page 743) is amended to include the settlements and small paddock to the north west of the village as shown on the attached settlement plan

## Reason for change:

The Lochhead Consultancy has fully engaged in the plan preparation process including responding to the publication of the Main Issues Report. It is now necessary to lodge a formal objection to seek the extension of the village envelope of St Cyrus as shown on the accompanying village map.

This proposed minor amendment to the village boundary was promoted at the Main Issues stage but was rejected by the Council on the basis that:

*“there is a defensible boundary to the north of the settlement with the road. There does not seem to be any advantage to moving the boundary to include the few properties to the north of the road.”*

Notwithstanding the comments of the Council the Lochhead Consultancy continues to consider that there is an opportunity to include the dwellings lying to the north west of the village within the village boundary. This would also allow the small paddock area to also be included within the settlement boundary.

The existing houses and paddock clearly relate to St Cyrus and the recent completion of housing site OP2 provides further justification for a change to the village envelope. It is not clear what the Council mean by the road forming a defensible village boundary as the proposed extension would not extend the village beyond the undeveloped road frontage lying to the west of the proposed village boundary extension. Indeed the proposal would fully comply with the vision outlined in the 'vision statement' for St Cyrus (page 740).

With a clear focus on the village boundary as defined in the Proposed Plan there does not seem to be any logic to exclude the dwellings and paddock as they clearly relate to the village. The proposed extension seeks to include a number of dwellings within the village who clearly form part of the village. The Council have failed to justify their exclusion to any great extent. The proposed extension of the village envelope will not extend the built up area beyond the most northerly dwelling while allowing the possibility for a small scale (two houses) within the paddock which logically forms a gap site.

The proposed minor but important alteration to the village boundary is both logical and more fully reflect the true extent of St Cyrus.

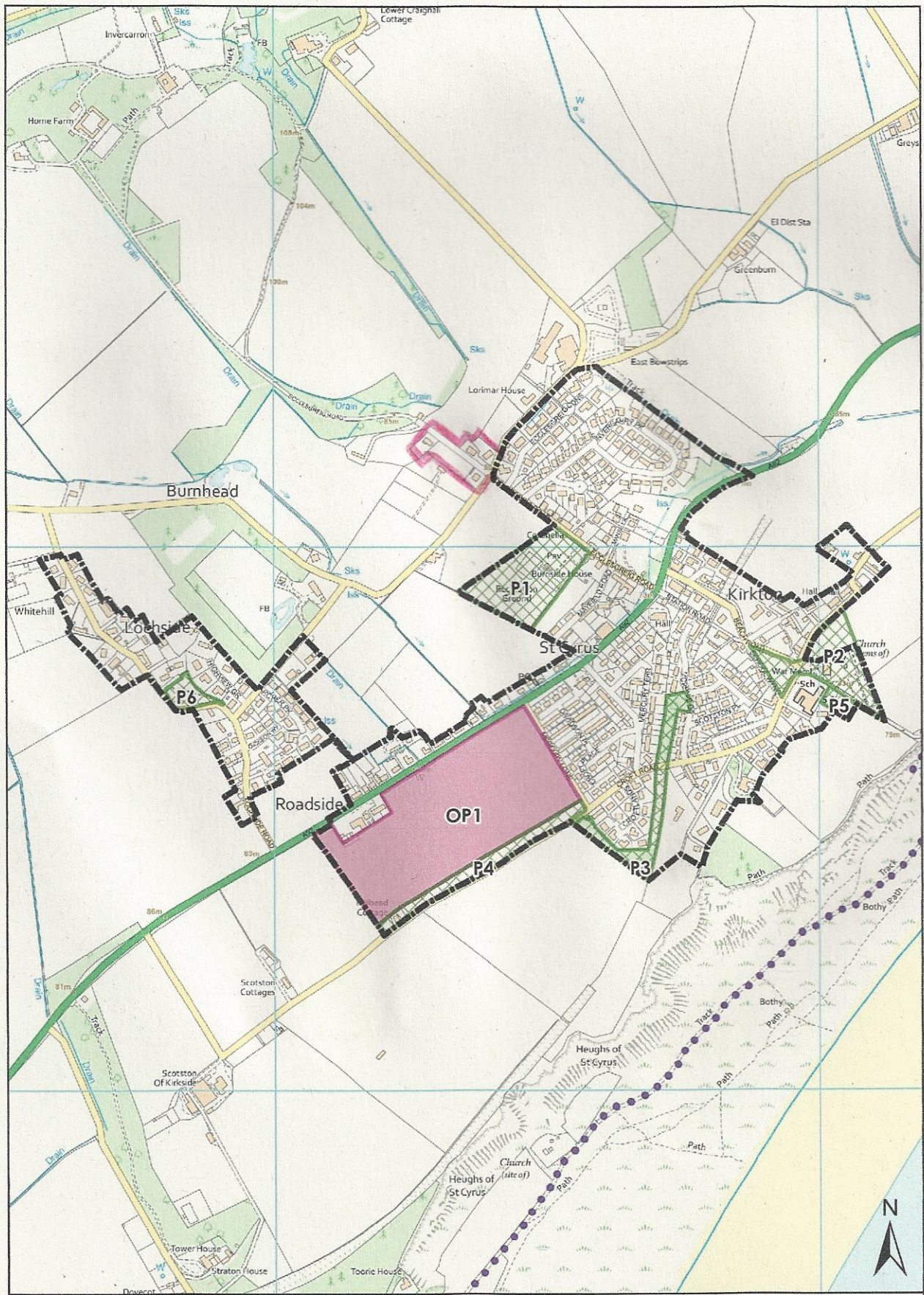
