

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

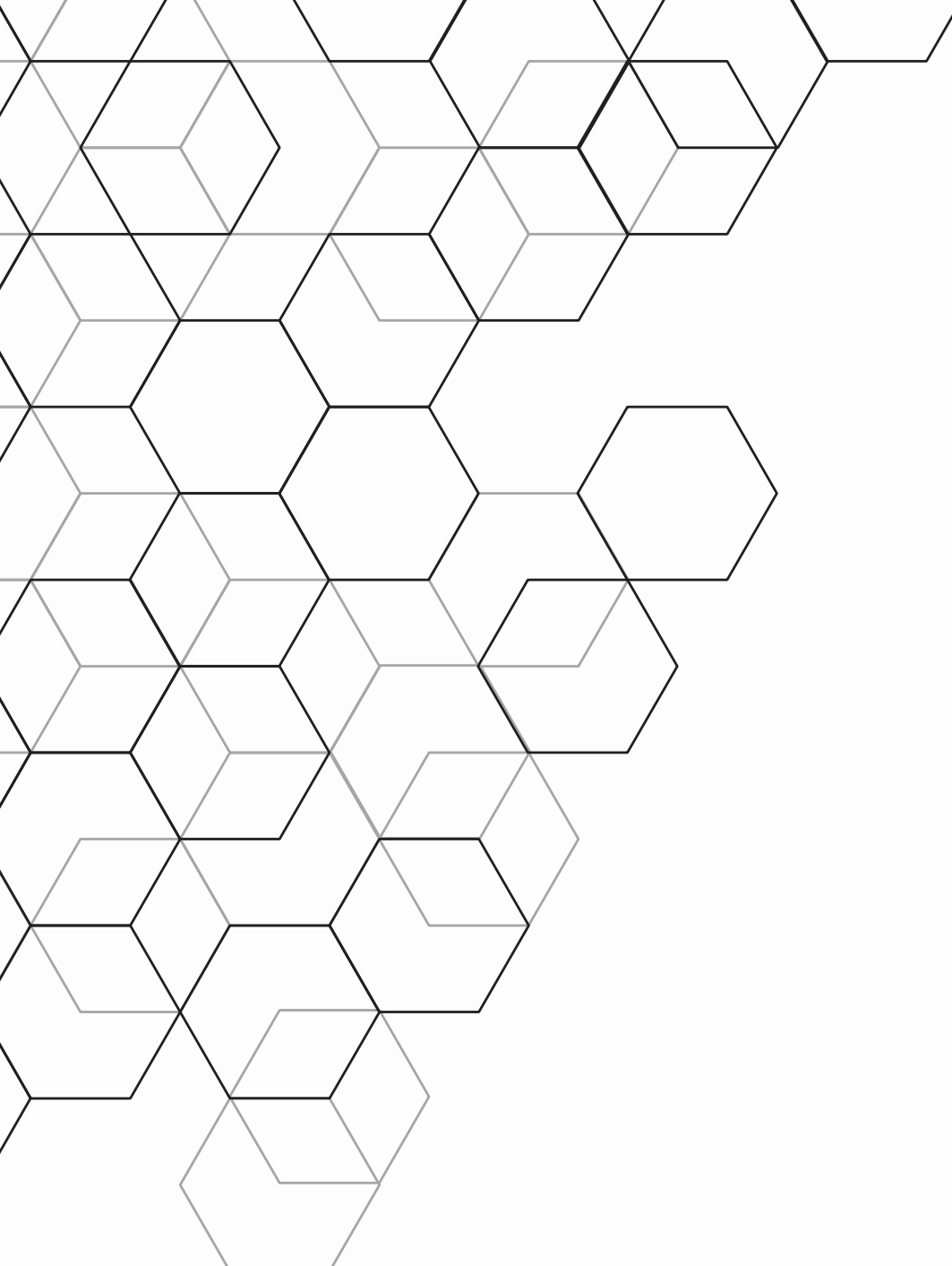

**ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2021
PROPOSAL FOR DEVELOPMENT AT SITE OP2, NEW PITSLIGO**

Further to your recent correspondence concerning the above referenced development proposal, I wish to express a number of concerns, including the negative impact to wildlife, the environment and the added pressure on local amenities.

The chosen development site will reduce the area of greenbelt available within the village and in particular, have a direct impact on the many forms of wildlife, who currently live on and make use of the land. Building on this land would cause extreme distress to local wildlife, leaving them with no home and forcing them to find somewhere else. There are a considerable number of different species of wildlife including Badgers, Foxes, Rabbits, Hedgehogs, Moles, Hares and Shrews, not to mention many different species of birds. There are also many species of insect which are good for the local environment, including bees and butterfly's, essential to a thriving environment. Considering much of the surrounding land is used as arable land, development of this land would further reduce availability of land for wildlife.

The erection of a further 90 houses within a small rural village will undoubtedly have a negative effect on the environment, as this will result in increased traffic with more people dependant on using cars, burning fossil fuels, increasing pollution and the carbon footprint.

Finally, there is a severe lack of amenities within the village with one school already at full capacity, how can the village possibly accommodate a further 90 homes and the families living within them. We have one shop in the village, therefore, once again increasing the dependence on using cars to travel to shops in the nearest town, approximately 12 miles away. The local bus service is limited, at best.

In my opinion, which having spoken with a number of residents within the village, appears to be shared, the impact on wildlife, potential effects on the environment and the severe lack of amenities do not present a credible case to proceed with this new development.

I would appreciate if you could take all the above factors into consideration when assessing the above development proposal.
