

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The proposed Community hub at Sauchen should be built on open land to the East of the village or on the Council owned land on Main Street adjacent to the car park, recycling bins and bus stop.

Reason for change:

The hub in Sauchen should not be in the last remaining green space in the Village. This will affect wildlife and those living nearby none of whom have been consulted in this Community project. Changing the status from P2 to R1 now means that this land could be built on at some stage either for Council or private use.

There has been no assessment of the impact on wildlife both flora and fauna. Habitats for birds, bats, and ground dwelling animals will be disturbed.

The hub plan shows the building next to houses that will now lose natural sunlight into their gardens and there has been no consideration for residents of the parking issue this will cause if the hub is introduced.
