

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I wish to comment on proposal for development of site OP1 Macduff as notified in your recent letter.

I note that field adjacent to Corksie Drive has now been designated as OP1(residential) & CC1 (commercial/retail) whereas before I understood in previous LDP the whole field was for commercial retail.

**Reason for change:**

I think that the proposal is poor development and does not make sense as the sketch attached to the letter seems to show a long access corridor with houses then overlooking the old railway line and path which runs from the main road to the rear of Corskie Drive. These houses would then be behind the remaining space for Commercial Retail which I find peculiar. I assume the commercial retail development would then have another access point to main road and would be subject to future development?

Ideally nimbyism would prevail but I think that if this site OP1/CC1 is to be developed it should be as a whole site for residential purposes given the proximity of the primary school and the new sports centre.

It seems to me that there is little demand for commercial retail development on this site as I have note from 2010 in this regard and I think it would be better designated for housing. This would I think lend itself to a more sympathetic development in keeping with the residential nature of the area.

I suspect the CC1 designated area would be further diminished in time and further housing developed in amore piecemeal fashion.
