

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Reason for change:

Concern re roads - where will the road access for the new development road be from? Depot Road/Clashmach View/Forest Way already can't cope with the volume of traffic, so another 50+ cars etc will cause a major problem. It effectively becomes single track due to parked cars on these roads and require to stop and wait to let cars past.

Concern re drainage – the current pumping/effluent station is not fit for purpose at present, the smell from there is sometimes stomach turning so another 50 houses are certainly not going to improve the situation.

Concern re Education – the current Primary & Secondary schools are certainly not fit for purpose and are falling far behind other towns in Aberdeenshire who seem to get new builds so again what will 50 houses put on the strain there

Concern re Broadband – not great at the best of times will be worse after 50 extra houses.

Is another housing development really needed with businesses leaving the town, Pipeline due to leave in September. Nothing in town centre to attract people to Huntly.

There are already empty houses in the town which have been sitting empty a long time.

If a new housing development is thought to be needed then was The Meadows not ear marked for development prior to the floods with roads and drainage already built? Surely with all the thousands of pounds having been spent on flood defences that is now a prime building site as infrastructure already exists. There is another plot for sale the other side of tesco.

The land was previously marked for industrial units, which would have been bad enough but now 50 houses added instead.
