

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

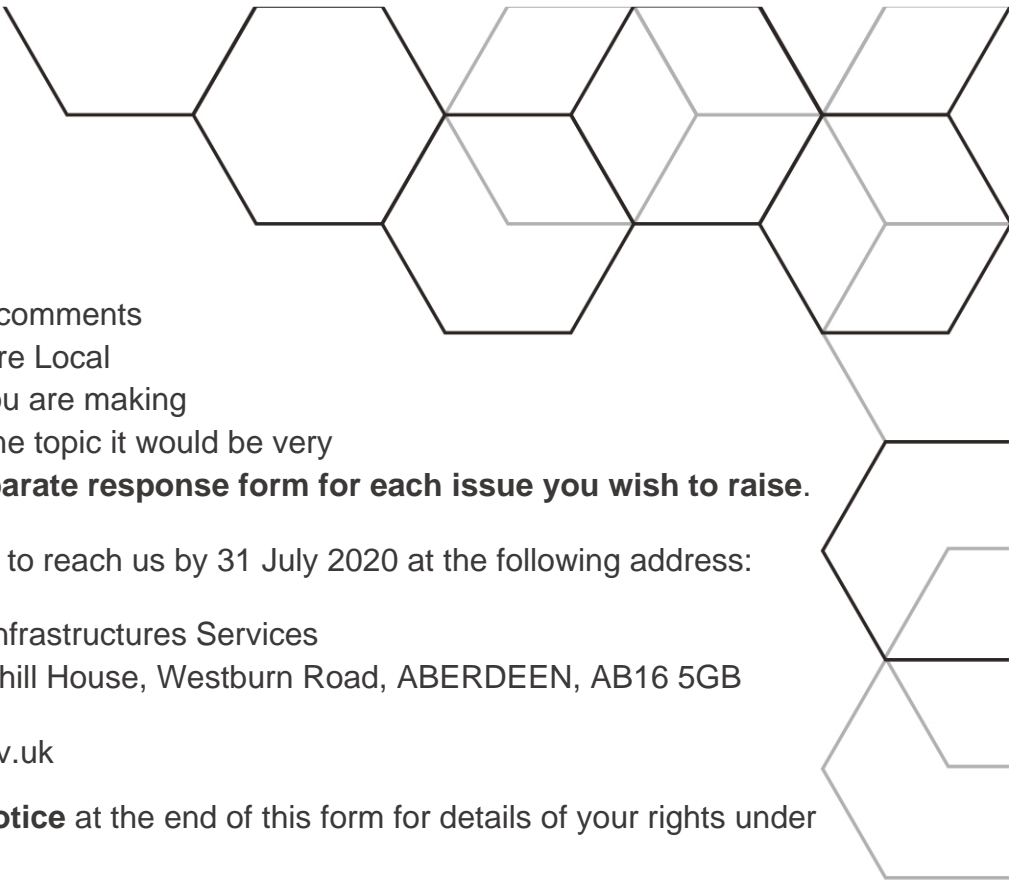

It is not a suitable area for a development of 11 houses and should be removed from your development plans on safety and overdevelopment grounds.

Reason for change:

The safety of our children is our primary concern. We live on [REDACTED] and all construction and residential traffic will come past our entrance. The proposed access is from the West side of Old Inn Road which as a private road is too narrow for the additional traffic (about 20 cars). It can not be widened due to the boundary's and there has been damage caused when [REDACTED] try to get lorries down. At the entrance to Earnsheugh Place there is a 3 way blind junction; we can not see traffic coming down nor they us. Traffic coming up from [REDACTED] or the proposed houses can not see around the corner nor traffic coming down see them. It will not be possible for the council to adopt Old Inn Road due to these safety issues and width. Our children use this road walking or on their bicycles and it would be irresponsible to add more traffic to an already blind and narrow road. Additionally the only road through Findon is narrow with two 90 degree bends with poor visibility; the proposed entrance for this site is on one of these bends. The National Cycle Route 1 uses this road and due to the bends and narrow extra traffic is a safety concern for cyclists also.

Additionally 11 houses would alter the character of Findon village. Previously planning application APP/2014/1850 was rejected on appeal with the following reason: "The proposals would have a detrimental effect on the character, environment and amenity of Findon by means of overdevelopment..." That was for 5 houses so it is even more relevant and true for this proposal.

The construction will cause heavy traffic which the roads are not suitable for and add to safety concerns. Also the noise and disruption will be significant.

The proposed site is poorly drained so attracts wildlife, it is near Findon Moor Site of Special Scientific Interest and Findon Local Nature Conservation Site but the field itself as a fallow field is a nature habitat.

Findon does not have street lighting and the residents requested it was not added so not to cause light pollution and keep with the rural ambiance. A development of 11 houses would require street lighting which changes the character of the village.

There is no need for additional housing in Findon and as the village has no amenities any requirements would be better served from Portlethen where there are several new developments.
