Dear Sir/Madam,

It has only recently come to my attention that a submission by CALA Homes in April 2019 for a new development proposal at Braehead Farm be included in the Local Development Plan by Aberdeenshire Council.

I have concerns over the intended development proposal which I set out as follows:-

I am a resident of the existing Braehead estate and have benefitted from the development but was appalled latterly, after moving to live there in 2010, when I realised that the planning consent and subsequent housing estate was unquestionably responsible for the extensive land slip resulting in the closure of the Bernie Braes road due to the alteration of the water retention of the Braehead area. This was due to the newly constructed houses and roadways not permitting water to naturally soak away. In addition, since the development of the Braehead estate, parts of the town of Stonehaven have now been seriously flooded on two occasions, despite the reassurance that these incidents were once in a hundred years occurrences! So despite the flood mitigation measures currently being undertaken it would be extreme folly for the Planning Department to permit any further development of the land perched above the town. Please let good sense prevail and finish the current flood prevention measures, then wait and see whether they work effectively over the next couple of decades before even considering further concreting over the remainder of Braehead Farm.

There is no mention of drainage impact assessment or flooding risk assessment within the planning application which is surely a major oversight from the developers.

There are more suitable areas for development *ie:-* the Ury Estate at Redcloak, where hopefully we will have some eagerly anticipated valuable local amenities created as well and no risk of flooding to surrounding properties or roads.

With the present huge downturn in the oil industry and the resulting job losses now, and in the longer term, why do we need even more new housing? Surely it is time to be cautious in face of the current economic climate, especially in Kincardine and Mearns, and decline this development proposal until there is a genuine requirement for yet more new houses.
