

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

APPENDIX 7D-SETTLEMENT STATEMENTS-GARIOCH.

Page 541. DURNO.

I wish the removal of the word 'significant' in the paragraph relating to development in the Settlement Statement

Reason for change:

The Settlement Statement in the Proposed LDP under the heading Vision for Durno contains the line. 'the settlement is not an appropriate location for **significant** new development'. This word, 'significant', was added after the Proposed LDP had passed all Council committee scrutiny and therefore the sentence with that word in it is not the settled will of the Council.

The MAIN ISSUES REPORT JANUARY 2019 worded it as 'Durno is **not considered suitable for development** due to the lack of local services'. In the report FINAL ISSUES-ACTIONS GARIOCH the wording is 'it is maintained that Durno lacks services and has limited public transport connectivity such that it is **not an appropriate location for further development**'.

The addition of the word 'significant' substantially changes the meaning of the sentence and was not approved by any of the Council committees.

I ask that the paragraph is returned to what was approved by Council and a more accurate wording of the Council's settled will would be '**Durno is not considered suitable for any further development**'.

All infill sites in the settlement have been identified and have been granted planning permission and there is no further land suitable for development other than encroaching on farmland. The issues with Durno have been well identified and previous submissions to the LDP process have detailed them. In that regard, the decision not to include the site applied for by developers is the correct one and I support that with the proviso that the sentence regarding further development is amended as detailed above.
