

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

No modifications required for Daviot, Appendix 7c, Formartine, as I support the Shire council's view, that bids FR018 and FR101 should not be recommended for development.

Reason for change:

The adverse impacts of FR018 and FR101, namely fundamentally changing the nature of Daviot village, using prime agricultural land, and having insufficient WWTW capacity mean that these developments would have an overall negative effect on the existing settlement. The addition of these developments would also cause a significant danger to both pedestrians and motorists, due to the narrow road access to the village at the entrances to these proposed developments.

The view expressed above is consistent with the majority of local Daviot residents as evidenced in the Future Vision Report by Meldrum, Bourtie & Daviot Community Council, published in 2017, compiled following a survey of local households.

In total, these two bids for the Daviot area includes 42 new houses, which seems completely disproportionate for a remote, small village, at a time when the oil industry is moving to a late life phase, the economy is struggling to recover post Covid 19 and houses are being built in large numbers in Inverurie. There are, at the time of writing, at least 10 houses for sale in the village, and several previously sanctioned plots have not been sold.

It is also worth noting that the Scottish Government overruled the Shire council to enable the development across the road from the FR101 site two years ago. This should be resisted as part of the 2020 LDP process.
