

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Removal of FR098 and indeed all proposals relating to building of houses at St Katherines, Formartine.

Reason for change:

The current community of St Katherines is less than 30 houses. As far as I'm aware all residents are happy to live there with the current infrastructure.

The current infrastructure is almost **NOTHING**; no shops, no pubs, no restaurants, no schools, no social or community facilities, no libraries, no leisure or children's play facilities, no places of worship, no mains gas supply and no mains sewage removal.

We do have one bus stop (for passengers travelling towards Aberdeen) requiring you to cross a busy main road and a few street lights.

This means that the residents are highly car reliant and undertake many frequent short and non-green car journeys to adjacent areas to access facilities and infrastructure not available in St Katherines.

All these journeys require the use of a dangerous road junction in order to access the main road, the A947. When turning right at the junction there is clear vision of approximately 120 metres for traffic approaching from the left. Vehicles travelling on the A947 at 50mph, go from out of sight to level with the junction in less than 6 seconds. It often feels like the simple task of turning right requires nerves of steel, lightning fast reactions and unnecessarily fast acceleration. This is exasperated in poor conditions such as rain, fog and low light levels. Additional vehicles in terms of the proposed houses will only increase the likelihood of accidents.

The development proposal also includes 1 hectare of employment land, given that the majority of neighbouring land is used for farming what type of employment would be available and why would someone want to start a business with no immediate infrastructure ?

There used to be a small garage that offered vehicle repairs, this has been considerably extended and is now a much larger engineering facility, despite providing employment it could be considered incongruous given the surroundings.

Instead of adding homes to an area with no infrastructure why not build onto existing local villages such as Oldmeldrum, Fyvie, Rothienorman, Methlick or Tarves ?
