

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The expansion of 25 housed of ECHT is proposed. I object as there is no clear public transport policy around the area.

Reason for change:

The area has had a clear expansion in the last few years. This has been good but however there has been no Public transport expansion to try meet any of these additional needs. Where there has been, is it been short lived, not publicised material. This lasted very little time due to lack of use. The existing twice a day service of home one in morning service and one service in the evening causing people who use it to be away for nearly 12 hours in the day is unacceptable. The dependency on Stagecoach to use the X 17 (or any other alternatives which they have started to use from the westhill) rather than Alford service seems to limit Echth public transport. This I feel put too emphasis on the people of an expanding village to keep using motor vehicles. We are told to use less but as there is no or limited transport how? Since the 23rd of March due to Corvid the so-called Echt and westhill service has actually not served Echt. The train station which is due to open soon in Kintore is it an ideal opportunity where an integrated transport system could be formed this could see that Banchory for example be used to enable some type of transport and picking up from other villages, including Echt towards Kintore so that some pressure could be taken off roads and put on trains. However Aberdeenshire Council seems unable seem unable to do. They seem happy to encourage that expansion of villages without the proper or any issues of public transport to addressed. I there fore object to the project.
