

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Site OP2 Hatton

This site has been earmarked for development for over ten years and has been a construction site for 4 years with only three houses being build (two of which are still unoccupied). We require that any future planning applications must include limitations on the time that local residents must endure living on the edge of a construction site with all the attending disruption. This could be for a further 10 years and is just unacceptable.

Reason for change:

Damage to infrastructure in Rowan Terrace, including pavements and roads. Developer claims no obligation to repair until completion of development (now to be 2031?). Severe flooding at foot of RT due to road not being completed (drains higher than street level). Developer claims no obligation to repair until completion of development (now to be 2031?).

Large unsecured areas containing building waste left open and untended (including a length of cable marked 'electric' lying above the surface, a danger to children and animals. Developer claims no obligation to repair until completion of development (now to be 2031?).

Refusal to carry out landscaping (and subsequent drastic loss of wildlife), resulting in the area being visually ugly and scarred. Developer claims no obligation to landscape until completion of development (now to be 2031?).

Pollution reducing lighting fitted throughout the village not extended to Rowan Terrace on the reason that unspecified electrical work will be required in future.(2031?).

Having to live in an active building site for up to another 11 years with all the danger, disruption, restriction of access, site traffic and mud that comes with that.

The traffic survey that the original development was based on was undertaken in 2008 (during the day when everyone was at work), however since then the demographics of RT has changed dramatically with pensioners and young families making up the majority of residents. Parking and access is already a source of tension with parts of the development being used to accommodate the surplus vehicles. Loss of this space plus the additional vehicles that the development will bring will cause severe parking and access problems. At present an ambulance attending a residence in parts of Rowan Terrace completely blocks the lower part of the street and the entirety of the new development. This has happened on several occasions already.

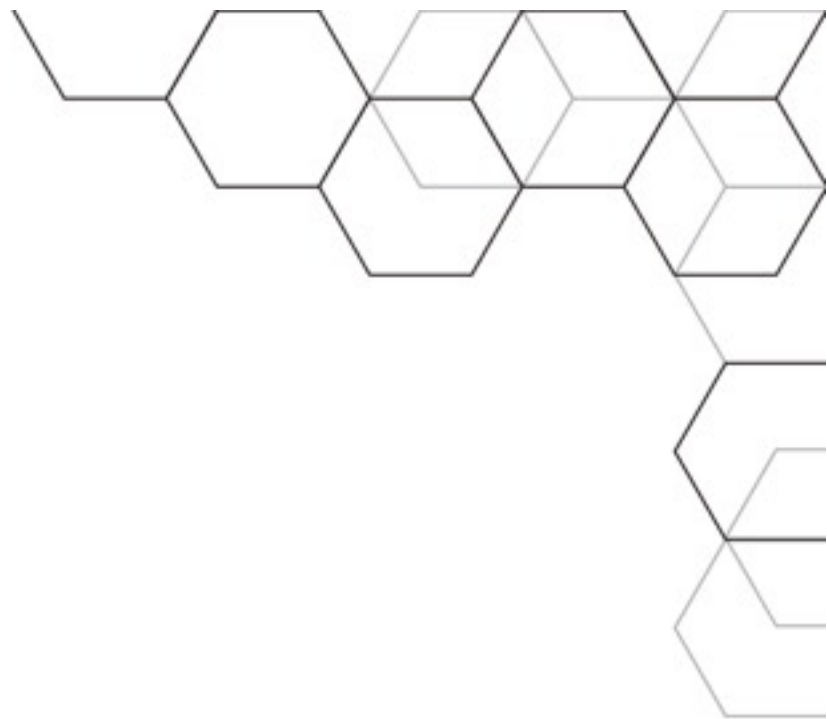
