

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

The modification for me to see is for the plans for a new housing scheme is to be scrapped.

The land that is being used for the LDP is right on my back garden and for many reasons I will not be happy if this planning goes ahead, along with all my neighbours along this side of the Main Street.

We built our house here 8 years ago and bought this plot due to the views out the back, this was the main reason and for the privacy.

The land mentioned at Teuchar road is on a hill and sometimes when there is lots of rain this land floods at the bottom and takes ages to go away

60 new homes means more impact on the local school which is adequately coping fine with amount of pupils as it is.

The sewer and waste water is coping just now but would be put to the limit if more houses were to be built.

It is mentioned that there is a shop and a hotel, the hotel is up for sale and the shop presents enough essentials and food for the local community as it is now, 60 new homes would put mere pressure on this wee village shop.

There is not enough bus transport and the locals struggle as it is getting transport in and out of the village on a regular basis...ie for young ones that could get more jobs if there was more transport.

The local amenities here like the tennis park hardly gets used as it is and there is nothing here for the kids to do apart from the small park for the young ones.

I had seen a plan once by the landowner at the local village hall and what all was being proposed and there is a main concern for myself and all the other neighbours in this side of the street.....the lanes from the main street would be used as access pathways to the village, and one of them lanes is where I live, therefore there would be all sorts of public walking back and fro every day and would totally lose all my privacy and noise levels would go up. I know all my neighbours have the same opinion on this !!!

This planning development would be far more suited for bigger towns like Turriff or Inverurie.ldp
