

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

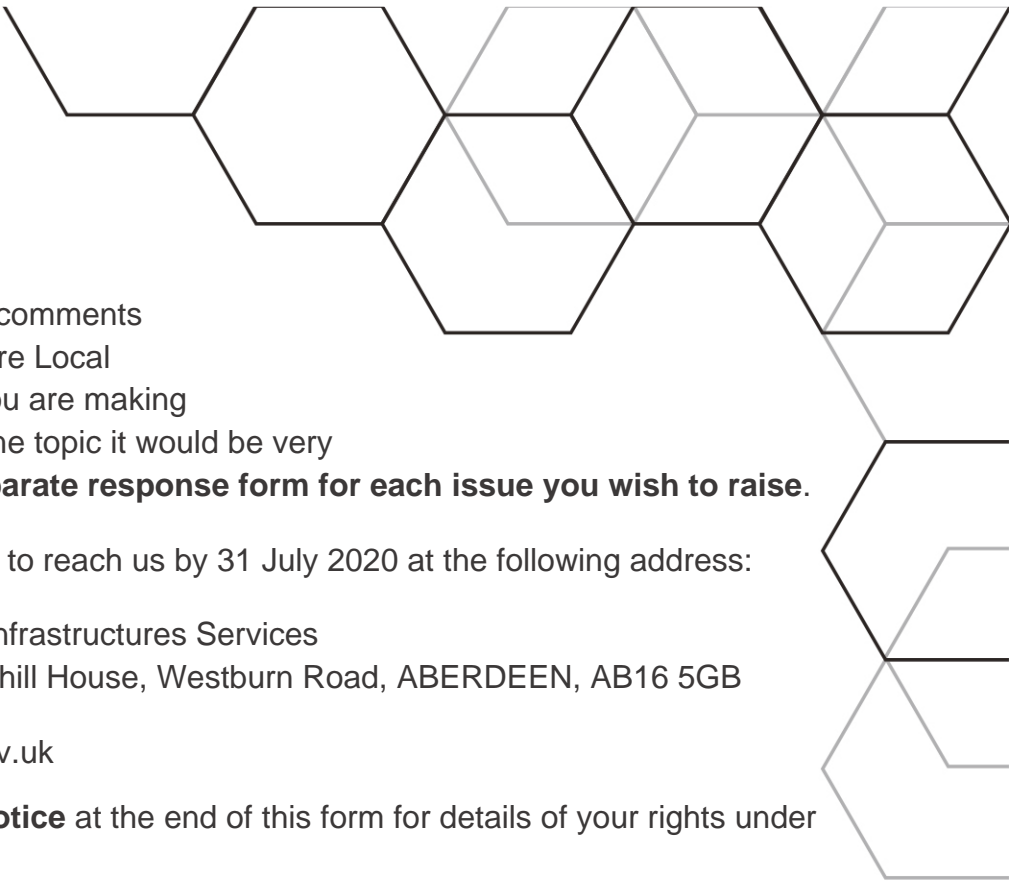

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Ref LDP2021NN – Appendix 7C Settlement Statement Formartine/Potterton pages 476-479. I object to the proposed plan to develop sites OP1 with 172 homes and OP2 with 61 homes.

## Reason for change:

The proposed area highlighted for development is Greenbelt designated and there is no justification for removing the Greenbelt status. Other sites are available in the area which are not Greenbelt designated. The development of OP1, 2 and the additional reserved status sites would double the size of the village. The scale of this increase is not justifiable when other sites are available.

I appreciate that due to the Covid19 pandemic, there has not been a public meeting with regards to the changes to be made to the village, but nevertheless, the community deserves more engagement than has been made accessible to them. Especially when this massive shift in the Local Development Plan for our area could be made to irrevocably change the future of this village.

The Government is currently promoting a greener future. If this development goes ahead, we will lose valuable green space and wildlife in our Ancient Woodland will suffer. Village residents will also suffer from construction contaminants during the long construction period.

I have been a resident of Potterton for 35 years and I enjoy walking along the country roads that surround the village. I have great concern regarding the safety of pedestrians and cyclists using these roads, with the expected increase of an additional 400+ cars, if the development goes ahead. I have already witnessed the increase in traffic on the 'C' class roads into the village from the AWPR and the difficulties that large vehicles have in passing when they meet head on. If large construction vehicles are to use these roads also, then the safety of all road users will be put at risk.

It is concerning to note that OP1 and OP2 lie within SEPA's 1 in 200-year Flood Risk Area. It is noted in the Strategic Environment Assessment report for Formartine that there would be localised impacts on watercourses during development, which is concerning when the sites border existing homes, Ancient Woodland and the protected species which live in the woodland.

There is no provision in the plan for increased amenities within the village. Current schools, roads and infrastructure could not support this development.

I moved to Potterton 35 years ago for the safety and security of living in a small rural community. This will be lost if the scale of this development goes ahead.
