

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

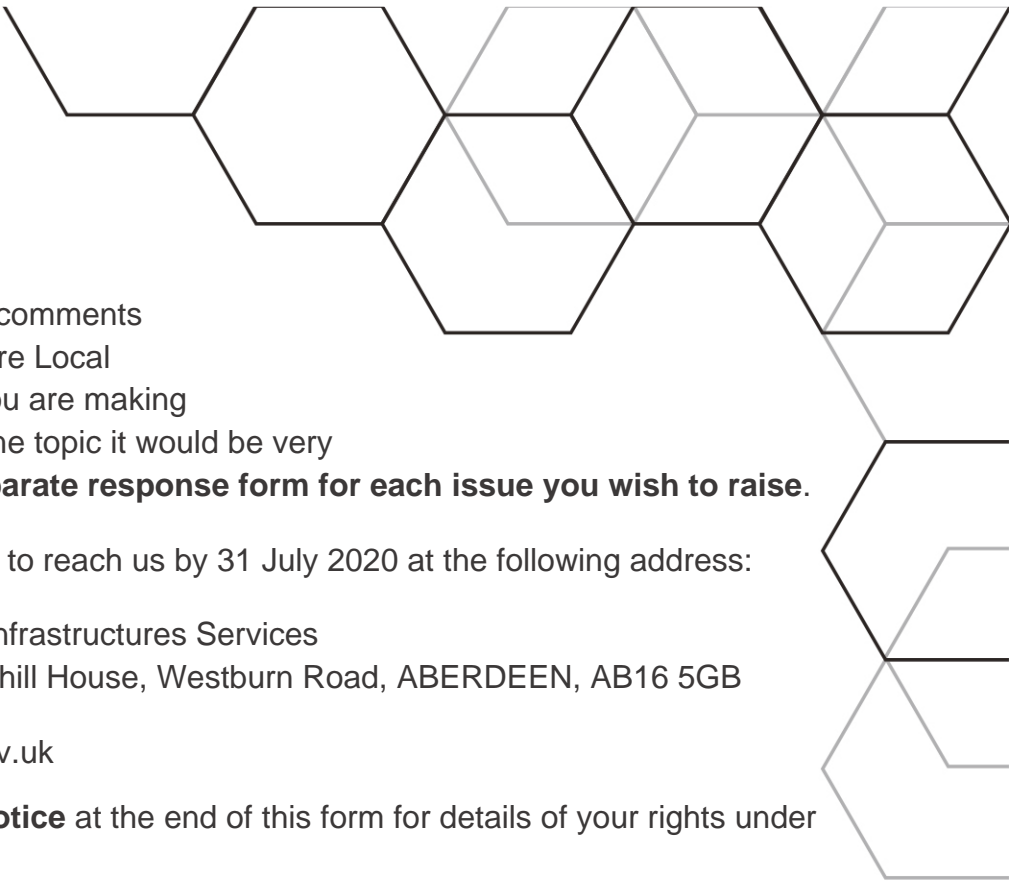

Ythanbank, Ellon OP1 5 houses  
Speed limit reduced to 30MPH from the Reindeer Centre entrance  
Pavement extended to same point

**Reason for change:**

Vehicles continually speed through the village, not reducing their speed until approaching the junction to Methlick. The approach to the village has 2 sharp corners and with the new entrances this will be very dangerous for cars exiting from the new houses. An extended speed limit area and perhaps some other traffic calming measures will help reduce their speed through the village.

A considerable number of walkers head along this part of the road to get to Shallowplough woods. It is already dangerous walking along the very narrow verge. With further traffic emerging on to this road and the 2 sharp bends it is vital that the pavement is extended to at least the entrance to Reindeer Centre.
