

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

As the home owner of the house that is surrounded by the proposed land for the Banff cemetery extension in R1 we would like further clarification on what ground tests will be carried out to determine which field will be used, and what could the risks to our health & safety/environment be?

At present our septic tank sits in the field adjacent to our property, if this were the preferred field, we would need to move the tank to another location, so would need to know who will be responsible for associated costs in moving it. We also currently have a boundary wall surrounding our property from the field. If this field is the preferred site for the cemetery what kind of privacy screening will be erected to ensure we or future owners of the property will not be visible to grieving families when we are in the garden. We also would like to know what parking amenities will be put in place, will the current road need to be reconfigured and will this impact on our environment around our location.

We also note the proposed development of 200 homes at Colleonard Drive, will the Wrack Woods be affected? We would also like to know what proposals there are for traffic access to this part of the town - will there be a bypass created? We have a small family so would need assurances that their safety would be considered as currently we are not eligible for free school transport due to boundary guidelines, so if they were to walk home from school there is currently no pavement or street lighting on the road to help keep them safe should they need to do this.

We look forward to hearing from someone in due course.
