RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

LDP 2021 Appendix 7C Potterton:

I would like development options OP1 and OP2 deleted from the LDP for Potterton, or at the very least significantly restricted so that only a small number of houses may be built.

(I have submitted 9 separate points by way of justification).

Reason for change:

1. Preservation of green-belt

OP1 and OP2 are on green-belt land, which should be preserved. The 2019 Main Issues Report (MIR) states that the planning objective for Potterton is to "preserve the amenity of the village ... through the application of the green-belt policy". In the absence of a demonstrable need for a major housing development at this location (see point 2), there is no justification for permitting OP1 or 2 on this land.

The 2016 DPEA report on Potterton recommended that the existing green-belt boundary should be preserved and there is no justification for changing this position.
